Description: The Building Advisory Board of Appeals has the jurisdiction to recommend that minor variances in the electrical, plumbing and mechanical application of the Building Code be granted and that alternative construction methods or materials be allowed. The board also recommends amendments to the Code.

Special Qualifications: None required by City Code; however, members appointed to the Building Advisory Board of Appeals should be qualified by experience and training to decide on matters pertaining to building construction.

Purpose:

Powers and Duties:

S.R.C. - Sec. 31-18. - Powers and duties.

The building advisory board of appeals shall:

(1) Determine the suitability of alternative materials and methods of construction when different than required in this chapter.

(2) Allow variances in the application of the provisions of this chapter to any individual case, when, in its opinion the enforcement thereof would do manifest injustice and would be contrary to the spirit and purpose of this chapter or public interest, or when, in its opinion, the interpretation of the building official should be modified or reversed.

Bylaws:

The Building Advisory Board of Appeals did not adopt bylaws. The Board adopted Rules and Regulations on December 15, 1983, and amended them on August 16, 2001, March 20, 2008, July 19, 2012 and February 15, 2018
