On June 23, 2009, Councilman Nelssen's item to discuss and possibly direct staff regarding the creation of a Downtown Task Force was approved by a Council vote of 5/2, with Councilmembers McCullagh and Ecton dissenting. It was noted at that meeting that the motivation for a Downtown Plan Task Force was to help facilitate, implement, and clarify some remaining vagaries in the recently adopted Downtown Plan. On July 2, 2009, the Council adopted Resolution No. 8027, creating the 2009 Downtown Task Force, and appointed the 15-member Task Force. In lieu of bylaws, the staff representative explained that the task force chair stated meeting protocols at their initial meeting on August 31, 2009.
