Plan, particularly in the area of neighborhood trails.

The task force charter describes the specific issues on which the Council was seeking input: 1)
Neighborhood trails implementation; 2) Updating the priorities for trails project identified in the
Trails Master Plan; 3) Updating and providing ideas on future trails projects; 4) Providing
information to update Trails Design guidelines, standards, and classifications; and 5) Identifying
and prioritizing funding sources for trails projects, reviewing maintenance and enforcement
activities.
