The Scottsdale Citizens' Bond Review Commission shall receive reports on the City's progress in implementing the proposed bond program, approved in Resolution No. 5535, dated May 1, 2000; review any project additions or deletions to the program and provide such comments to the City Council as the commission deems appropriate in respect to the program.

Bylaws:

The Citizens Bond Review Commission adopted bylaws on January 10, 2002 and amended them on November 1, 2007 and August 6, 2009.

Bylaws Provisions:

Organization: officers, vacancies, candidacies for elective public office, committees, legal counsel

Clarification of meeting times, locations and procedures: quorum, member attendance, order and notice of business matters

Official records: definition, public records, recording of vote

Rules and amendments: amendment procedure, copy of rules and regulations, Robert's Rules of Order, written communications, interpretation and conflict

Absences (Bylaws): If a member is absent without being excused by the Chairperson from two (2) consecutive regular meetings, or from any four (4) meetings within a 12-month period, the Chairperson shall, following the Commission's recommendation for removal, notify the Council for consideration of removal and replacement of the member.

Notes:

On October 16, 1989, the City Council adopted Ordinance No. 2268, establishing the Citizens Bond Review Commission to monitor projects to be funded by the November 1989 bond election. The first commissioners were appointed on January 16, 1990.

On May 1, 2000, the City Council repealed Ordinance No. 2268 and adopted Ordinance No. 3322, establishing a new Citizens Bond Review Commission. The commissioners were initially appointed on January 23, 2010.

On March 1, 2011, the Council adopted Ordinance No. 3922 terminating the Citizens Bond Review Commission.
