On May 3, 1993, the Council adopted Ordinance No. 2527 creating the board.

On June 22, 1993, the Council made the first appointments; however, only six initial appointments are reflected in the minutes.

On July 1, 2002, Council adopted Ordinance No. 3450 repealing Chapter 2, Section 7 of the Scottsdale Revised Code, which established the Endowment Advisory Board. Mayor Manross noted that members had voted to sunset the board and transfer remaining funds to the Arizona Community Foundation for administration.
