Purpose:

S.R.C., Sec. 2-294. Purpose.

It shall be the purpose of the EMSD Commission to act as an advisory body to the City Council on matters concerning the expenditure of revenues from assessments collected within the boundaries of the Enhanced Municipal Services District (EMSD) in accordance with Title 48, Chapter 4, Article 2, Arizona Revised Statutes, and all amendments thereto.

Powers and Duties:

S.R.C., Sec. 2-296 Powers; duties; jurisdiction

- (a) The EMSD Commission may adopt rules and regulations to govern its affairs. These rules and regulations shall provide time and place of its meetings and such other matters relative to its work and administration of its duties which are not otherwise provided for by statute, ordinance or resolution.
- (b) The EMSD Commission shall elect its own chairman and vice-chairman for one year terms. A designee of the City Manager shall serve as the city staff liaison of the EMSD Commission.
- (c) The EMSD Commission shall recommend to the City Council an annual budget for marketing and special events from revenues from the EMSD assessment. Such funds shall be used for the purpose of promoting the EMSD area as a destination and attract visitors to the area.

On November 4, 2003, Council adopted Ordinance No. 3532 creating the Enhanced Municipal Services District Commission.

On December 8, 2003, the Council made the initial appointments to the commission.

On May 17, 2005, Council adopted a resolution for a \$0 assessment, effectively ending the Enhanced Muncipal Services District and the need for a commission. Council indicated it preferred to find other options for marketing and promoting downtown.

As of November 2, 2010, the Council has not repealed S.R.C. Ch. 2, Div. 7, Sections 2-294 to 2-296 creating the Enhanced Municipal Services District Commission.
