Powers and Duties:

S.R.C., Sec. 2-333. - Purpose; powers and duties.

The Scottsdale Housing Board may:

- (1) Review current conditions and make recommendations to the City Council regarding objectives for the mix and affordability of housing stock in the City of Scottsdale;
- (2) With the assistance of City staff, advise the City Council on all housing issues, including but not limited to the following matters:
 - a. Housing grant policies and funding strategies for housing programs;
 - b. Diversity of the housing stock in Scottsdale;
 - c. Funding strategies for housing programs;
 - d. Identification of strategies to address barriers to housing affordability;
- e. Recommending policies for encouraging housing revitalization and protection of existing housing stock; and
 - f. Other housing-related issues and matters as the City Council may direct.

Notes:

On June 15, 1992, Councilmember Bielli suggested the possibility of forming a Housing Board. The February 23, 1993 minutes mention the "proposed Housing Board." On May 3, 1993, Council adopted Ordinance No. 2531 establishing the Housing Board. On June 14, 1993, Council adopted Ordinance No. 2569 increasing the membership of the board from five to seven members. On June 22, 1993, Council made the first appointments to the Board.

On June 17, 1969, the Council voted to appoint Dick Campana, Ron Butler, Pete Merlino, Carol Kratzet, and Joe Alvarez to the Housing Board. This does not appear to be the same public body. There are no other references to a Housing Board from that time period. Mr. Campana's resignation from the 'House Code Board' was contained in the July 21, 1970 Council minutes. No appointments were found after 1969, until 1993. The appointments from 1969 are not included in the membership of the board established in 1993.

The commission will make recommendations to the City Council on specific programs which are designed to prevent the decline and deterioration of neighborhoods by empowering the residents to help themselves. Notes:

On November 27, 1990, staff member Jerry Stabley presented the recommendations of the Neighborhood Preservation Task Force Report, including that the Neighborhood Beautification Committee be incorporated with the Take Pride in Scottsdale program or serve as an oversight committee for the Neighborhood Enhancement Program. On January 29, 1991, the Council discussed the work plan for the Neighborhood Enhancement Committee. On October 5, 1992, the Council voted to extend the Neighborhood Enhancement Committee and the members terms until April 5, 1993. On February 23, 1993, the Council discussed a plan to change the status of the committee to a commission. On May 3, 1993, the Council adopted Ordinance No. 2530 establishing the commission.

- (a) It shall be the purpose of the Scottsdale Pride Commission to:
- (1) Promote public interest through education for improvement of the environment and the quality of life within the City of Scottsdale;
- (2) Initiate, plan, and coordinate programs for litter control in conjunction with and in cooperation with citizens, City departments, other governmental entities, businesses and industries within the City limits of Scottsdale;
- (3) Develop plans for improving the health, sanitation, safety and cleanliness of the City of Scottsdale by beautifying the streets, highways, alleys, stream banks, lots, yards and other similar localities;
- (4) Aid in the removal and elimination of trash and other debris from the streets, highways, stream banks, alleys, lots, yards and other similar places;
- (5) Encourage the placing, planting and/or preservation of trees, flowers, plants, shrubs and other objects or ornamentation in the City in keeping with the City's tree City designation;
- (6) Advise and recommend plans to the City Council for beautification of Scottsdale and otherwise promote public interest in the general improvement of the environment of the City of Scottsdale.

Powers and Duties:

Sec. 2-378. - Powers and duties.

- (a) In order to accomplish its purpose, the commission shall have the authority to:
- (1) Plan, initiate, direct and coordinate community-wide efforts in furtherance of its purpose.
- (2) Solicit and accept donations and appropriations of money, services, products, property and facilities, on behalf of the City, for expenditure and use by the commission for the accomplishment of its purposes in accordance with city regulations.
- (3) Make recommendations to the City Council concerning matters and on measures that are within the

Take Pride in Scottsdale Committee bylaws were adopted on March 15, 1993. Scottsdale Pride Committee bylaws were amended (date unknown), on Janauary 26, 2006, and again on May 6, 2010.

On March 15, 1993, Council adopted Resolution No. 3755 establishing the Take Pride in Scottsdale Committee. Formal appointments for the committee cannot be found until January 18, 1994. In the minutes of the committee, the original name was retained through the minutes of November 30, 1995. The December minutes reflect a name change to Scottsdale Pride Committee. No discussion regarding the name change was located.

On July 10, 2007, Council adopted Ordinance No. 3732, establishing the Scottsdale Pride Commission. On July 8, 2008, the Council adopted Ordinance No. 3794 modifying the membership from 15 to 11.
