On April 27, 1987, staff proposed a Neighborhood Beautification Program based on the results of a citizen survey in which considerable interest was expressed for having such a program. On June 1, 1987, Council adopted Ordinance No. 1959, creating a five-member Neighborhood Beautification Awards Committee. On September 15, 1987, Council adopted Ordinance No. 1978, increasing the size of the committee from five to nine members. At the same meeting, the Council made the initial committee appointments. The committee presented an update to City Council on June 20, 1988 according to Council minutes. Appointments were made for both new and returning members on June 6, 1989. On January 15, 1991, Council presented Plaques of Appreciation to Marilyn Armstrong, Norman Krasnow, La Junta Monroe, Greg Bielli, Mike Saager, June Meyer, Andrea Forman, and Nancy Cantor for their service on the Neighborhood Beautification Committee.

On November 27, 1990, it was recommended that the Neighborhood Beautification Committee be incorporated with the Take Pride in Scottsdale program or serve as an oversight committee for the Neighborhood Enhancement Program.

Chairman Marilyn Armstrong expressed the committee's desire to stay involved and active. Councilmember Campana emphasized a desire for the committee to continue to be active. Councilmember Bielli stated it was his hope the City Council would appoint a citizens task force/advisory group in January 1991. He commented that the task force could ultimately become a commission. City Manager Jorge Carrasco suggested staff bring back in January a recommended charge for the Neighborhood Beautification Committee.

On January 29, 1991, the Council discussed a work plan for the Neighborhood Enhancement Committee.
