On May 9, 1978, Council authorized Mayor Drinkwater to sign a letter, which among other things, established an ad hoc Scottsdale Airport Noise Abatement Advisory Committee.

No initial appointments of the committee were found.

On October 6, 1980, the Council voted to expand the number of members of the Noise Abatement Committee from nine to eleven; decrease the number of fixed-base operators to one; and, increase northeast Scottsdale homeowners to three. The motion carried 6/1, with Mayor Drinkwater dissenting. It was noted in the minutes of that meeting that the selection practice for committee members was to accept recommendations from the Airport Director.

On October 14, 1985, the Council voted to approve the bylaws of the committee. No record of the bylaws themselves has been located.

On July 17, 1989, Councilmember Deibel questioned the infrequent meeting schedule of the committee and asked for confirmation that they had not met since January. City Manager Carrasco confirmed that, and stated the next meeting was scheduled for July 20, 1989. He said the committee had not had a quorum with which to conduct business.

On October 23, 1989, James Harris with Coffman Associates (Airport Consultants) reported that the committee was very knowledgeable and had performed a good job as part of an overall report on several airport issues.

The exact disposition of the committee is unknown. The last mention of the committee was on January 21, 1997. Mr. Burt Koester spoke at a Council meeting and was referenced as a member of the Noise Abatement Committee.
