There is no record of a formal creation of the SC-3 of the Cable Television System prior to appoinments being made.

On May 17, 1982, Ms. Kay Stevens of United Cablevision gave a brief overview of the proposed Cable Television System and said she was there to request that Council appoint members to the proposed boards: Cable Television Citizen Commission, Management Committee, Development Services Board, and the Scottsdale Community Cable Corporation (SC-3).

On July 6, 1982, the Council appointed members to all four proposed boards.

One February 4, 1985, Council approved Articles of Incorporation and Bylaws for Scottsdale Community Cable Corporation. On May 6, 1985, Council voted to amend the bylaws of SC-3.

On December 14, 1987, Council discussed alternatives to SC-3. Dick Bowers explained that discussions had been held with United Cable, in order to amend the license agreement with the possibility of eliminiating SC-3 funding in favor of a franchise agreement.

On April 4, 88, Council adopted Resolution No. 3022 authorizing the City to enter into agreement 870382 with United Cable Television and adopted Ordinance No. 2006, amending the cable television license agreement. Ordinance 2006 removes any reference to SC-3.
