Absences (Ordinance No. 1582): If a member is absent or tardy from two (2) consecutive meetings or from three (3) meetings within a one-year period, then the Chairperson shall notify the mayor or the mayor's designee so that consideration of removal and replacement of the member may be scheduled for City Council action. If the City Council has approved alternates to serve in the event of a vacancy, the Task Force may appoint a replacement member from the list of approved alternates.
