

RESOLUTION NO. 7735

A RESOLUTION OF THE COUNCIL OF THE CITY OF SCOTTSDALE, ARIZONA, DECLARING THE OFFICIAL CANVASS OF VOTES CAST IN THE CITY OF SCOTTSDALE GENERAL ELECTION HELD SEPTEMBER 2, 2008; AND DECLARING TWO CANDIDATES FOR THE OFFICE OF MAYOR AND SIX CANDIDATES FOR THE OFFICE OF COUNCIL MEMBER IN THE RUNOFF ELECTION TO BE HELD NOVEMBER 4, 2008.

WHEREAS, pursuant to Article 9, Section 1 of the Scottsdale City Charter, the City of Scottsdale, Arizona, held a General Election on September 2, 2008, for the purpose of electing a mayor and three council members for the City of Scottsdale; and

WHEREAS, A.R.S. § 16-642 requires that the City Council canvass the returns of the election no later than twenty (20) days following the election; and

WHEREAS, the City Council, having canvassed the returns of the General Election, finds the returns to be as stated in this resolution; now, therefore, be it

RESOLVED by the Council of the City of Scottsdale as follows:

1. The results of the canvass having been determined, the official canvass of the City of Scottsdale General Election held on September 2, 2008 is as follows:
 - a) A summary of the number of votes cast in each district for each candidate for the offices of mayor and council member is shown on Exhibit A, which is attached and incorporated by this reference.
 - b) A precinct group detail of the number of ballots cast and number of rejected ballots by district is shown on Exhibit B, which is attached and incorporated by this reference.
2. The following named candidates, having received the greatest number of votes cast in the General Election, which number was less than the majority of all ballots cast, will be candidates at the Runoff Election, to be held on November 4, 2008 for the office of mayor:





UNA RESOLUCIÓN DEL CONCEJO DE LA CIUDAD DE SCOTTSDALE, ARIZONA, DECLARANDO EL ESCRUTINIO OFICIAL DE LOS VOTOS EMITIDOS EN LA ELECCIÓN GENERAL DE LA CIUDAD DE SCOTTSDALE QUE SE CELEBRÓ EL 2, DE SEPTIEMBRE DE 2008; Y DECLARANDO DOS CANDIDATOS PARA EL CARGO DE ALCALDE Y SEIS CANDIDATOS PARA EL CARGO DE MIEMBRO DEL CONCEJO EN LA ELECCIÓN FINAL QUE SE CELEBRARÁ EL 4 DE NOVIEMBRE DE 2008.
