INTRODUCTION

To the Voters of the City of Scottsdale:

This pamphlet provides you with information regarding the City of Scottsdale's November 8, 2022 General Election to elect a Councilmember. In the August 2, 2022 Primary Election, there were seven residents running for three seats on the City Council. Two candidates, Kathy Littlefield and Solange Whitehead, received a majority of the legal votes cast in the election and were elected. The next two candidates receiving the highest number of votes, Pamela Carter and Barry Graham, advanced to the General Election.

This pamphlet contains general voting information regarding voting options and key dates. Also included in the pamphlet are statements prepared and submitted by each of the candidates for this election. Candidate statements represent the opinions of the authors and have not been edited or checked for accuracy of content. The order of the candidate statements was determined through a random drawing.

All qualified electors of the City may vote for one council candidate. A qualified elector of the City is defined as a person, eighteen years or older, whose name appears on Maricopa County's list of registered voters in a City of Scottsdale precinct 29 days prior to the date of election. To vote in the City's November 8, 2022 General Election, Scottsdale residents must be registered to vote by Tuesday, October 11, 2022.

You are encouraged to read all the material contained in this pamphlet and to exercise your right to vote in Scottsdale's November 8, 2022 General Election.

IMPORTANT VOTING INFORMATION

NOVEMBER 8, 2022 GENERAL ELECTION

The City of Scottsdale will hold a General Election on November 8, 2022 to elect one Councilmember. In the August 2, 2022 Primary Election, two candidates, Kathy Littlefield and Solange Whitehead, received a majority of the votes cast in the election and were elected. The next two candidates receiving the highest number of votes, Pamela Carter and Barry Graham, advanced to the General Election. All three candidates elected in 2022 will begin their terms in January 2023.

QUALIFICATIONS TO VOTE

To vote in this election, you must be registered to vote in Scottsdale by Tuesday, October 11, 2022. You may check your registration status at [BeBallotReady.Vote](https://www.maricopa.gov/BeBallotReady.Vote) or by calling 602-506-1511.

EARLY BALLOTS

Ballots will be mailed on Wednesday, October 12, 2022 for voters who are on the Active Early Voting List (AEVL). Voters not on the AEVL may request an early ballot at [BeBallotReady.Vote](https://www.maricopa.gov/BeBallotReady.Vote) or by calling Maricopa County at 602-506-1511. Early ballots must be requested by Friday, October 28, 2022.

REQUESTING BALLOTS BE SENT TO AN ALTERNATE (TEMPORARY) ADDRESS

The U.S. Postal Service cannot forward ballots to another address. If you would like to receive a ballot for this election at a temporary address, please contact Maricopa County at 602-506-1511.

RETURNING VOTED EARLY BALLOTS

Return your voted early ballot in the ballot affidavit envelope that was provided with the ballot. Make sure to sign, date, and provide a phone number on your affidavit envelope. To be counted, voted ballots must be received by Maricopa County no later than 7:00 p.m. on Election Day. If you return your voted ballot by mail, be sure to allow sufficient time for delivery by mailing your ballot by Tuesday, November 1, 2022. Also, you may drop off voted ballots at any voting location or ballot drop box listed on this page.

CHECKING THE STATUS OF YOUR BALLOT

Information on the status of your ballot is available online at [BeBallotReady.Vote](https://www.maricopa.gov/BeBallotReady.Vote), where you may obtain detailed information, such as the date your ballot was mailed, received, processed, and tabulated. Date of Election **Tuesday, November 8, 2022**

In this Election, Scottsdale voters will elect one Councilmember. The candidate receiving the majority of legal votes cast in the November Election will take office in January 2023.

Military and Overseas Ballots Mailed **Saturday, September 24, 2022**

The Uniformed and Overseas Citizens Absentee Voting Act (UOCAVA) requires that ballots be sent to UOCAVA voters (active members of the Uniformed Services) at least 45 days before an election.

Last Day to Register to Vote **Tuesday, October 11, 2022**

Include your full name, residence address, and date of birth for verification purposes.

Last Day to Request a Ballot by Mail or a Replacement Ballot **Friday, October 28, 2022**

If you did not receive your ballot or need to request a replacement, call 602-506-1511 or go online at [Request.Maricopa.Vote](https://www.maricopa.gov/Request.Maricopa.Vote) through 5:00 p.m. on Friday, October 28, 2022. After this date, you may request a replacement ballot at one of the voting locations indicated on page 2.

Recommended Date to Mail Completed Ballots **Tuesday, November 1, 2022**

It is recommended you mail your ballot at least 7 days before Election Day.

Ballot Must Be Received By **7:00 p.m., Tuesday, November 8, 2022**

For your ballot to be valid and counted, your voted ballot and signed affidavit must be received (POSTMARKS DO NOT COUNT) by the Maricopa County Elections Department by 7:00 p.m. on Election Day, Tuesday, November 8, 2022. You may also deposit your ballot and affidavit at any voting location or drop box location before the 7:00 p.m. deadline.
