**Description:** The Transportation Commission advises the City Council on matters relating to the safe and

efficient movement of vehicles, transit, pedestrians, and bicycles. The Commission provides a

public forum to hear citizen complaints and requests regarding transportation matters.

**Purpose:** 

The purpose, powers and duties of the Transportation Commission are combined in Sec. 2-283.

#### **Powers and Duties:**

Sec. 2-283. - Purpose; powers and duties.

- (A) The Transportation Commission shall advise the City Council on matters relating to the safe and efficient movement of motor vehicles, public transportation, which includes but is not limited to pedestrians, bicycles, equestrians and trail users upon designated paths and trails, streets and all elements of the transportation network of the City; the transportation master plan in accord with the community mobility element of the general plan; and the City's capital improvement program and operating budget for transportation. This includes as needed issues involving the City's intelligent transportation systems efforts, aesthetics along roadways such as landscaping and new transportation facilities and surface transportation infrastructure improvement and/or routine maintenance. Nothing in this section shall be construed to require that the Transportation Department's or its successor agency's budget be precluded from going through the normal budgetary process used by the City prior to Transportation Commission review or infringe upon the City Manager's budgetary responsibilities under the City Charter. The Transportation Commission shall provide a public forum to hear citizen comments and requests regarding transportation matters. The duties of the Commission shall include, but shall not be limited to, the following:
- (1) Recommend to the City Council, annually, a prioritized five-year capital improvement program for transportation, including an analysis of funding resources.
- (2) Recommend to the City Council, annually, a prioritized one-year capital improvement program for transportation for the coming fiscal year, including analysis of funding resources.
- (3) Recommend to the City Council, periodically, as appropriate, a prioritized implementation program and updates for the transportation master plan.
- (4) Review periodically the DS&PM (Design Standards and Policy Manual) as it relates to transportation, and the community mobility element of the general plan and transportation master plan or subsequent guiding policy documents regarding transportation and make appropriate comments and recommendations.

- (5) Make recommendations to ensure that the City's street system is accessible for all users, providing "complete streets". Complete streets are defined per the most recently adopted transportation master plan, and will be modified by reference with revisions to the transportation master plan.
- (6) Review matters concerning mobility and safety and make recommendations to the City Council regarding measures that should be taken to promote mobility and safety within the City.
- (7) Provide a public forum to hear citizen comments and requests regarding transportation matters on existing and potential or new transportation facilities related to mobility, and make recommendations to the City Council, as appropriate, as to the disposition of such citizen concerns.
- (8) A Paths & Trails Subcommittee of the Commission is hereby established to advise the Commission as a whole and provide a public forum for issues surrounding paths and trails. The Subcommittee shall consist of five (5) members. Two (2) of the members shall be Transportation Commissioners appointed by the Transportation Commission Chair. One (1) member shall be a Parks and Recreation Commissioner appointed by the Parks and Recreation Commission Chair. These three (3) members will be appointed annually. Two (2) non-commissioner members apply and are appointed by City Council for a term of three years, maximum of two terms. The Chair shall be a Transportation Commissioner selected by the Transportation Commission Chair.
- (9) Review this division periodically and make such recommendations as to its revision as may be deemed necessary and appropriate to further its goals.
- (10) Reasonable efforts will be made to bring to the Commission any transportation budget information in a timely manner.
- (11) Take any such further actions as may be deemed necessary and appropriate to further the goals of the Commission.

## **Bylaws:**

The Transportation Commission adopted bylaws December 1, 1988, amended March 2, 1995, May 15, 1997, July 16, 1998, May 18, 2006, and April 12, 2010.

## **Bylaws Provisions:**

Organization: Elections, officers, vacancies, Commission coordinator, committees

Clarification of meeting times, locations and procedures: quorum, member attendance, public comment, presentations, time limitations

Official records: definitions, recording of vote, public record

Rules and amendments: Robert's Rules of Order, written communications, interpretation and conflict

Absences (Bylaws): If a member is absent from four (4) consecutive meetings or five (5) meetings within a sixmonth period, in the absence of exceptional circumstances, the member's office shall be automatically vacated and a new member shall be appointed by the Council. Any question regarding what constitutes an exceptional circumstance shall be decided by the Chair. The Chair or Commission Coordinator shall notify the City Clerk's Office of the vacancy.

On February 8, 1988, Council began discussions on a possible Transportation Commission. The topic was brought up frequently during the spring of 1988. On September 19, 1988, Council adopted Ordinance No. 2046

establishing the Transportation Commission. The Council made the first appointments on October 18, 1988.

On November 3, 2009, the Council adopted Ordinance No. 3870 which amended and restated the purpose, powers, and duties of the Transportation Commission, including establishing a Trails Subcommittee. On May 6, 2014, the Council adopted Ordinance No. 4148 which amended and restated the purpose, powers, and duties of the Transportation Commission, including establishing a Paths & Trails Subcommittee.
