

RESOLUTION NO. 8517

A RESOLUTION OF THE COUNCIL OF THE CITY OF SCOTTSDALE, ARIZONA, DECLARING THE OFFICIAL CANVASS OF VOTES CAST IN THE CITY OF SCOTTSDALE GENERAL/SPECIAL ELECTION HELD NOVEMBER 2, 2010; AND DECLARING THE ELECTION OF THREE COUNCILMEMBERS.

WHEREAS, pursuant to Article 9, Section 1 of the Scottsdale City Charter, the City of Scottsdale, Arizona, held a General Election on November 2, 2010, for the purpose of electing three councilmembers and submitting two bond questions and seven propositions to the voters; and

WHEREAS, on June 15, 2010, the Mayor and Council of the City of Scottsdale adopted Resolution No. 8335 entitled, "Resolution ordering and calling a special bond election to be held in conjunction with the City of Scottsdale, Arizona General Election on November 2, 2010 to submit to the qualified electors thereof the questions of authorizing the issuance and sale of \$63,600,000 principal amount of General Obligation bonds"; and

WHEREAS, the two bond questions were submitted to the voters at the November 2, 2010 General/Special Election as Question 1 and Question 2; and

WHEREAS, on July 6, 2010, the Council unanimously adopted Ordinance No. 3903, entitled, "An ordinance of the Mayor and Council of the City of Scottsdale, Arizona, calling a special election for November 2, 2010; proposing seven amendments to the City Charter; and submitting the proposed amendments to a vote of the qualified electors of the city at a special election to run concurrently with the November 2, 2010 General Election"; and

WHEREAS, the seven charter amendments were submitted to the voters at the November 2, 2010 General/Special Election as Propositions 411 through 417; and

WHEREAS, A.R.S. § 16-642 requires that the City Council canvass the returns of the election not less than six (6) days nor more than twenty (20) days following the election; and

WHEREAS, the City Council, having canvassed the returns of the General/Special Election, finds the returns to be as stated in this resolution; now, therefore,

BE IT RESOLVED by the Council of the City of Scottsdale as follows:

1. The results of the canvass having been determined, the official canvass of the City of Scottsdale General/Special Election held on November 2, 2010 is as follows:

- a) A summary of the number of votes cast in each precinct for each candidate for council, each bond question, and each proposition is shown on Exhibit A, which is attached and incorporated by this reference.
 - b) A precinct group detail of the number of rejected ballots by precinct is shown on Exhibit B, which is attached and incorporated by this reference.
2. The following three named candidates, having received the first, second, and third highest number of votes cast in the General Election for the office of councilmember, were elected to four-year terms:

Linda Milhaven
Bob Littlefield
Dennis Robbins
 3. Question 1, which seeks voter authorization to sell \$36,600,000 general obligation bonds for streets, transportation improvements and drainage facilities, having received a number of votes that was less than a majority of the votes cast, was rejected by the qualified voters.
 4. Question 2, which seeks voter authorization to sell \$27,000,000 general obligation bonds to refinance existing obligations incurred by the City to finance public safety facilities and equipment, having received a number of votes that was less than a majority of the votes cast, was rejected by the qualified voters.
 5. Proposition 411, which specifies that the City may exercise condemnation only if it is authorized by the state, if it is for a public use, if all reasonable options have been exhausted to avoid the use of condemnation, and if its use is narrowly tailored to advance the public use, having received a number of votes that was more than a majority of the votes cast, was approved by the qualified voters.
 6. Proposition 412, which specifies that the City cannot give its credit or make any payments of any public funds to any individuals or entities unless there is a clearly identified public purpose and the City either receives direct consideration substantially equal to its expenditure or provides direct assistance to the needy, having received a number of votes that was more than a majority of the votes cast, was approved by the qualified voters.
 7. Proposition 413, which provides for a public comment period at regular council meetings, remove the thirty-day requirement to act on petitions, and allow the council to request staff to review any matter brought to its attention, ask that the matter be placed on a future agenda, or take no action, having received a number of votes that was less than a majority of the votes cast, was rejected by the qualified voters.
 8. Proposition 414, which places all sections related to the charter offices in one article; identifies their duties and responsibilities; requires City residency for all officers of the City; identifies the treasurer as the chief financial officer; and removes the council's express

authority to combine the duties of separate charter offices, having received a number of votes that was more than a majority of the votes cast, was approved by the qualified voters.

9. Proposition 415, which clarifies that council members and appointed public officials shall not control or demand the appointment or removal of city employees subject to the direction and supervision of any city officer, with the exception of city employees whose primary duties are to directly serve the mayor or council, having received a number of votes that was more than a majority of the votes cast, was approved by the qualified voters.
10. Proposition 416, which clarifies that the council may act by motion, in addition to resolution and ordinance; designates which actions require an ordinance; specifies when a majority vote is required; removes obsolete language; and makes various administrative changes that add clarity to existing language regarding ordinances and resolutions, having received a number of votes that was more than a majority of the votes cast, was approved by the qualified voters.
11. Proposition 417, which sets the initial term of the presiding judge at two years, with subsequent terms set by ordinance, but not less than two years; permit additional judges to be appointed as provided by ordinance; and designate that the council determines all judges' compensation and may remove them for cause, having received a number of votes that was more than a majority of the votes cast, was approved by the qualified voters.




