PUBLIC COMMENT: One written public comment was received.

1) Approve Regular Meeting Minutes for December 13, 2023

Chair Brady made a motion to approve the Regular Meeting Minutes from December 13, 2023 as revised, with Commissioner Coletta providing a Second for the motion, which carried 7-0. All members present voted for APPROVAL.

2) Election of Officers

The Commission will vote to elect the Chair and Vice Chair for 2024.

Candidates who have been nominated to date and have expressed willingness to serve (by position) include: Ute Brady (Chair) plus Walter Cuculic and Andrew Scheck (Vice Chair). Each position is open for additional nominations prior to voting, either through self-nomination or by a fellow commission member.

Commissioner Cuculic withdrew himself for consideration as Vice Chair. No other nominations were received.

Commissioner Cuculic made a motion to elect Commissioner Brady as Chair and Commissioner Scheck as Vice Chair, with Vice Chair Chrisman Lazarr providing a Second for the motion, which carried 7-0. All members present voted for APPROVAL. Chair Brady retained the position of Chair, and Vice Chair Scheck immediately took over the position of Vice Chair.

3) Scottsdale Community Sustainability Plan

Lisa McNeilly, Sustainability Director, will continue discussion on the remaining three sections of the Scottsdale Sustainability Plan (Energy, Waste and Heat).

6) Update to 2024 Meeting Schedule

The Commission will discuss and possible approve an additional meeting to the 2024 schedule of a Special Meeting in January or February.

Chair Brady made a motion to add a Special Meeting on January 31, 2024 at 5:30 p.m. to discuss the sustainability plan, with Commissioner Coletta providing a Second for the motion, which carried 7-0. All members present voted for APPROVAL. Note that this item was heard before Item #2 Election of Officers.

7) Staff Updates
