#### **OLD BUSINESS**

APPROVED: 4-0; Board Member Mosser moved to approve the minutes of the November 7, 2018 meeting with the recommended change as presented. Chair Suzanne Welch seconded the motion.

# **NEW BUSINESS**

APPROVED: 4-0 Board Member Mosser moved to nominate Suzanne Welch as Vice Chair and Richard O'Conner as Chairman. Board Member Welch seconded the motion

2. Review, discuss and take action on further recommendations to the City Council for changes to the Loss Trust Fund Document, Code and Ordinance. Motion to approve or disapprove.

APPROVED: 3-1 Board Member O'Connor made a motion to accept the recommendation to reverse the name and experience changes as previously

recommended to continue forward with the changes under items 3,4, & 6 and to modify #5 the recommendation on Lien Settlement from \$20,000 authority to an unlimited authority. Suzanne Welch seconded the motion.

3. Review and discuss Fiscal Year 2017/18 medical plan premiums - Information Item.

## OPEN CALL TO THE PUBLIC (A.R.S. § 38-431.02)
