1. Call to Order/Roll Call – 9:01AM

3. Election of Chair and Vice-Chair

COMMISSIONER ALSPAUGH MOVED TO RE-APPOINT CHAIRPERSON HENRY AS THE CHAIRPERSON. COMMISSIONER MINEER SECONDED. THE MOTION CARRIED BY A VOTE OF SIX (6) TO ZERO (0). CHAIRPERSON HENRY ABSTAINED.

CHAIRPERSON HENRY MOVED TO RE-APPOINT VICE-CHAIR NEWMAN AS VICE-CHAIR. COMMISSIONER ALSPAUGH SECONDED. THE MOTION CARRIED BY A VOTE OF SIX (6) TO ZERO (0). VICE-CHAIRPERSON NEWMAN ABSTAINED.

4. FY2023/24 Tourism Program Budget

Karen Churchard, Tourism & Events Director, presented the FY 2023/24 Tourism program budget.

6. Tourism Development Commission Annual Report

7. Scottsdale Arabian Horse Show Tent Rental Funding Request

Taryl O'Shea, Scottsdale Arabian Horse Show, gave a presentation requesting recommendation to City Council for bed tax expenditure up to \$60,000 to support the tent cover rental fee for arena 7 for the 2023 Scottsdale Arabian Horse Show.

COMMISSIONER SHAFFER MOVED TO RECOMMEND FUNDING UP TO \$60,000. COMMISSIONER MONTGOMERY SECONDED THE MOTION. THE MOTION CARRIED BY A VOTE OF SEVEN (7) TO ZERO (0).

8. Scottsdale International Jazz Festival New Event Funding Request

Doc Jones, Scottsdale International Jazz Festival, and his guests gave a presentation requesting a recommendation to City Council for bed tax expenditure up to \$75,000 to support a one-year event funding agreement.
