BOARD MEMBER CAVNER MOVED TO APPROVE THE INDUCTION OF NEW SCOTTSDALE FIREFIGHTER RECRUIT NICHOLAS BRIGHT, WITH AN EFFECTIVE DATE OF MARCH 1, 2021. HE WILL BE INDUCTED WITH PRE-EXISTING CONDITIONS, IF ANY, AS NOTED ON THE LISTING THAT IS INCLUDED WITH THE BOARD PACKET. BOARD MEMBER SPRINGBORN SECONDED THE MOTION, WHICH CARRIED THREE (3) TO ZERO (0) BY ROLL CALL VOTE. CHAIR MERAZ, BOARD MEMBERS CAVNER AND SPRINGBORN VOTED IN THE AFFIRMATIVE. THERE WERE NO DISSENTING VOTES.

3. Discussion and vote on the Normal Retirement application of Fire Marshal Deputy Tamala S. Rosenhagen

Ms. Sampson noted that Fire Marshal Deputy Tamala S. Rosenhagen retired on March 4, 2021 with 25.047 years of service. Her monthly benefit is \$4,984.55. All of her paperwork is in order.

4. Discussion and vote on the Normal Retirement application of Deputy Fire Chief Joseph Early

Ms. Sampson noted that Deputy Fire Chief Joseph Early will retire on March 31, 2021 with 21.183 years of service. His monthly benefit is \$5,846.19. All of his paperwork is in order.

THERE WERE NO DISSENTING VOTES.

Chair Meraz thanked Deputy Chief Early for his years of service.

5. Discussion and vote on the Deferred Retirement Option Plan (DROP) application Fire Engineer Michael J. Adamo

Ms. Sampson noted that Fire Engineer Michael J. Adamo entered the DROP January 16, 2021 with 20.070 years of service. His monthly benefit will be \$3,797.61. All of his paperwork is in order.

Ms. Sampson said that Fire Marshal Deputy Tamala S. Rosenhagen purchased 4.370 years of service from Rural Metro before her retirement.
