BOARD MEMBER HEEREN MOVED TO APPROVE THE INDUCTION OF NEW SCOTTSDALE POLICE OFFICER RECRUIT MICHAEL CARIVEAU AND DANNY DONOVAN WITH AN EFFECTIVE DATE OF MAY 24, 2021, AND CHRISTIAN NOSEWORTHY AND BLAKE RUIZ WITH AN EFFECTIVE DATE OF JUNE 7, 2021. EACH WILL BE INDUCTED WITH PRE-EXISTING MEDICAL CONDITIONS, IF ANY, AS NOTED ON THE LISTING THAT IS INCLUDED WITH THE BOARD PACKET. BOARD MEMBER PALIWODA SECONDED THE MOTION, WHICH CARRIED FOUR (4) TO ZERO (0) BY ROLL CALL VOTE. CHAIR MERAZ, BOARD MEMBERS STROBECK, PALIWODA, AND HEEREN VOTED IN THE AFFIRMATIVE. Ms. Sampson noted that Police Officer Gary A. White passed away July 8, 2021. The surviving spouse benefit is \$3,578.22. All paperwork is in order.

BOARD MEMBER PALIWODA SECONDED THE MOTION, WHICH CARRIED FOUR (4) TO ZERO (0) BY ROLL CALL VOTE. CHAIR MERAZ, BOARD MEMBERS STROBECK, PALIWODA, AND HEEREN VOTED IN THE AFFIRMATIVE. THERE WERE NO DISSENTING VOTES.

Chair Meraz offered condolences to the White family on behalf of the Board and the City of Scottsdale.

4. Discussion and vote on the DROP (Deferred Retirement Option Plan) termination and Normal Retirement Application of Police Lieutenant Daniel E. Rincon

Ms. Sampson noted that Police Lieutenant Daniel E. Rincon will retire on July 29, 2021 with 25.003 years of service. His monthly benefit is \$6,188.47. All of his paperwork is in order.

BOARD MEMBER PALIWODA MOVED TO APPROVE THE DROP TERMINATION AND NORMAL RETIREMENT APPLICATION OF POLICE LIEUTENANT DANIEL E. RINCON. BOARD MEMBER STROBECK SECONDED THE MOTION, WHICH CARRIED FOUR (4) TO ZERO (0) BY ROLL CALL VOTE. CHAIR MERAZ, BOARD MEMBERS STROBECK, PALIWODA, AND HEEREN VOTED IN THE AFFIRMATIVE. THERE WERE NO DISSENTING VOTES.

Chair Meraz thanked Lieutenant Rincon for his years of service and wished him a happy retirement.

5. Discussion and vote on the DROP (Deferred Retirement Option Plan) Application of Police Sergeant Jason A. Devlin

Ms. Sampson noted that Police Sergeant Jason A. Devlin entered the DROP on June 5, 2021 with 21.669 years of service. His monthly benefit is \$5,442.63. All of his paperwork is in order.
