THERE WERE NO DISSENTING VOTES.

# 2. Induction of new City of Scottsdale Firefighters into PSPRS, if any

BOARD MEMBER STROBECK MOVED TO APPROVE THE INDUCTION OF NEW SCOTTSDALE FIREFIGHTER RECRUITS JACOB DODGE AND CASEY KUNSZT WITH AN EFFECTIVE DATE OF JULY 19, 2021, AND RICHARD BORUNDA, BRANDON ROLLINS, LOGAN DAOUST, ELIZABETH DEADMAN, RAUL SCHCOLNICK, AND RORY WIRTH WITH AN EFFECTIVE DATE OF AUGUST 2, 2021. EACH WILL BE INDUCTED WITH PRE-EXISTING MEDICAL CONDITIONS, IF ANY, AS NOTED ON THE LISTING THAT IS INCLUDED WITH THE BOARD PACKET. BOARD MEMBER SPRINGBORN MOVED TO APPROVE THE ISSUANCE OF AN INDEPENDENT MEDICAL EXAMINATION THROUGH ONE OF THE BOARD'S CONTRACTED MEDICAL PROVIDERS FOR THE APPOINTMENT OF A MEDICAL SPECIALIST TO SERVE AS A MEDICAL BOARD FOR THE ACCIDENTAL DISABILITY RETIREMENT APPLICATION OF FIREFIGHTER DANNY J. RAMIREZ. BOARD MEMBER CAVNER SECONDED THE MOTION.

Board Member Strobeck mentioned that this was his first time reviewing a disability application. The Board briefly reviewed the IME process.
