#### 23. Public Hearing on and Adoption of Proposed Fiscal Year 2013/14 Budget (Tentative Budget)

- Councilman Littlefield moved to cut funding for the Scottsdale Cultural Council by \$800,000. The motion died for lack of a second.

- Councilman Phillips moved to direct the City Manager to develop a budget that is balanced and sustainable. The motion died for lack of a second.

- Councilwoman Milhaven moved to adopt Ordinance No. 4087. Councilmember Korte seconded the motion, which failed 2/5, with Mayor Lane; Vice Mayor Klapp; and Councilmembers Littlefield, Phillips, and Robbins dissenting.

- Mayor Lane made an alternate motion to adopt Ordinance No. 4087, removing eight positions and using the one-time funding for overtime at Fire Station 602. Councilman Robbins seconded the motion, which failed 3/4, with Councilmembers Korte, Littlefield, Milhaven, and Phillips dissenting.

- Councilmember Korte made an alternate motion to increase property taxes to a maximum of 2%, as allowed by state statute, to fund eight positions at Fire Station 602. The motion died for lack of a second.

- Councilwoman Milhaven moved to amend her original motion to adopt Ordinance No. 4087, with the understanding that the eight positions at Fire Station 602 and the Fire Marshal position will be paid in the current year out of one-time monies. The motion died for lack of a second.

- Councilman Littlefield moved to cut funding for the Scottsdale Cultural Council by \$800,000. The motion died for lack of a second.

- Councilwoman Milhaven moved to adopt Ordinance No. 4087, reducing contingency from \$5.0M to \$4.0M. Councilmember Korte seconded the motion. No vote taken.

- Councilman Phillips made an alternate motion to adopt the budget, with a stipulation that the Acting City Manager find \$800,000 in savings over the next year that is sustainable. The motion died for lack of a second.

- Councilman Littlefield made an alternate motion to pass the budget and hope that the City Manager can come up with \$800,000. Councilman Phillips seconded the motion. No vote taken.

- Councilman Robbins made an alternate motion to adopt Ordinance No. 4087, modifying it so that Fire Station 602 will be staffed using one-time overtime funds of up to \$425,000, and then, as the City Manager sees opportunity to save ongoing expenses, hire full-time employees to the appropriate staffing levels. Vice Mayor Klapp seconded the motion, which carried 5/2, with Councilmembers Littlefield and Milhaven dissenting.

- Vice Mayor Klapp moved to call the question. Councilwoman Milhaven seconded the motion, which carried 5/2, with Councilmembers Littlefield and Phillips dissenting. Requests:

 The City Council solicits and receives public input relative to the entire Proposed FY 2013/14 Budget, which includes both the Operating Budget and Capital Improvement Plan. The City Council may direct Staff to make revisions to the Proposed FY 2013/14 Budget prior to adoption or may adopt proposed version as the Tentative Budget required for conformity with Arizona Revised Statutes and City Charter.  Adopt Ordinance No. 4087 as presented, or as modified by Council, establishing the Tentative Budget for FY 2013/14. Establishment of the Tentative Budget statutorily fixes the maximum expenditure limit. The maximum expenditure limit may still be lowered by Council before final budget adoption. Adoption of Ordinance No. 4087 also directs the City Clerk to meet obligations regarding publication and notices imposed by Arizona Revised Statutes or City Charter. Through adoption of Ordinance No. 4087, Council also tentatively adopts the Proposed FY 2013/14 Classification/Compensation Plan in conformity with Scottsdale Revised Code Sec. 14-20, et. seq.
