Government Accounting Standards Board Statement No. 68 effective FY 2014/15:


In just 10-years, pension contributions (by the City and its employees) have increased from \$6.9 million to \$36.3 million!











AZ Retirement Plans

- Normal retirement as young as age 40: no reduction in retirement benefit for age.
- Unlimited retirement benefit at any normal retirement age
- Benefit based on avg. 3 or 5 year highest earnings
- o Payroll Cost:
 - o 21.8% ASRS (10.9%+10.9%)
 - o 33.5% Police (23.9% + 9.6%)

Federal Social Security

- Normal retirement at age 66: 25% reduction in benefits at age 62
- o Maximum \$30,396 annual benefit at age 66
- Benefit based on avg. 10-35 year earnings
- o Payroll Cost:
 - o 12.4% FICA (6.2%+6.2%)

The current program is unsustainable, yet...
