MORE RECENTLY IN THE CITY OF PRESCOTT I SERVED ON THE BOARD OF ZONING APPEALS FOR TEN YEARS. I HAVE ALSO SERVED ON THE ECONOMIC DEVELOPMENT COMMITTEE UP THERE. I ALSO SERVED ON THE BOARD OF THE HUMANE SOCIETY IN YAVAPI COUNTY. I'M DOING SOME CONSULTANT WORK FOR FREE ON SOME CONSTRUCTION PROJECTS RIGHT NOW. I HAVE A FULL SCOPE OF ALL THAT'S NEEDED TO BE ON THIS COMMITTEE. I THINK I'M VERY WELL QUALIFIED. I BELIEVE THAT THE IMPORTANT THING IS TO ADHERE TO THE ZONING CODES AND HAVE CONFORMANCE TO THE MASTER PLAN AND I THINK THIS IS AN IMPORTANT AREA THAT SHOULD BE CONSIDERED. THIS IS MY HOME NOW AND MY FAMILY WILL SEE THAT THIS IS FOR MANY MANY YEARS TO COME. EIGHT OF OUR TEN CHILDREN LIVE AND GO TO SCHOOL HERE AND WORK HERE AND WANT TO HAVE SOME PART OF THE FUTURE AND STAYING AND WORKING AND LIVING IN THIS GREAT COMMUNITY. WE WANT TO MAKE SURE THAT I CAN PARTICIPATE AND LOOKING AT THE VISION AT COMPLETING THE VISION AND BE PART TO PARTICIPATE IN THE VISION OF THE SCOTTSDALE FOR THE NEXT 20 OR 30 YEARS, NOT ONLY FOR MYSELF BUT FOR THE COMMUNITY OF THE FUTURE GENERATIONS TO COME. WHAT EXPERIENCES DO I HAVE, I AM A REGISTERED

ARCHITECT IN THE STATE OF ARIZONA FOR OVER 35 YEARS. I HAVE A GOOD EXPERIENCE IN WORKING AND COMING BEFORE THE BOARD OF ADJUSTMENT, REZONING AND UNDERSTANDING THE PROCESSES, OF GETTING SOME OF THE WORK DONE. I HAVE ALSO VOLUNTEERED IN MANY PUBLIC ORGANIZATIONS THROUGHOUT PIMA COUNTY, CITY OF TUCSON AND THE STATE AND HAVE A GREAT UNDERSTANDING OF THE PROCESSES AND THE LEGALITIES AND THE CONFLICTS OF INTEREST AND MORE IMPORTANTLY THE TIME COMMITMENT TO SERVE ON SUCH A BOARD OR COMMISSION. Saiid Mahmud: THANK YOU FOR THE OPPORTUNITY. MY NAME IS SAJID MAHMUD. SCOTTSDALE IS MY HOME. I HAVE SERVED ON MULTIPLE BOARDS BEFORE IN MY CAREER AND ALSO IN THE SOCIAL NETWORKS. I AM A CERTIFIED PROJECT MANAGER AND I HAVE DONE PROJECT MANAGEMENT. I HAVE OWNED A FEW BUSINESSES IN THE CITY OF SCOTTSDALE WHICH HAS GIVEN ME A PLATFORM WHERE WE CAN INTERACT WITH COMMUNITY AND PUBLIC AFFAIRS. IT WOULD GIVE ME A GOOD OPPORTUNITY TO DIVERSIFY WITH VARIOUS DIFFERENT FOLKS. I SEE THE CURRENT BOARD IS PRETTY STRONG, HOWEVER, WE CAN ADD MORE LEADERSHIP VALUE TO MAKE IT STRONGER. THE TOPOGRAPHY THOSE CONCERNS COME IN THE LAND HAS NOTHING TO DO WITH THE PROPERTY OWNERS. SO I APPEAL THE BOARD TODAY NEEDS TO BE A LITTLE BIT MORE OPEN MINDED AND WITH THEIR APPROACH TOWARDS PRIVATE PROPERTY OWNERS' RIGHTS AND AT THE SAME TIME TO KEEP THE CITY'S INTEGRITY AND THE NEIGHBORING OWNERS OF THE CITY OF SCOTTSDALE THEIR RIGHTS. SO I BELIEVE BRINGING THOSE CHANGE ON THE BOARD IS DEFINITELY GOING TO ADD MORE VALUE. LOOKING INTO THE ISSUES, I GOT A REALLY GOOD SKILLS FOR THAT AND I DEFINITELY GOING TO ADD VALUE TO THAT. Paul Garry: GOOD AFTERNOON, MY NAME IS PAUL GARRY. I HAVE LIVED IN SCOTTSDALE FOR THE PAST 6 YEARS. I CAME TO SCOTTSDALE BECAUSE IT'S WHERE I HAD LONG WANTED TO LIVE. SCOTTSDALE HAS A UNIQUE COMBINATION OF CULTURE, CASUAL SOPHISTICATION, CLIMATE AND COMMERCE. I WANT TO SERVE ON THE BOARD OF ADJUSTMENT BECAUSE I WANT TO HELP PRESERVE THE CHARACTER AS A PHENOMINAL PLACE TO LIVE FOR ALL OF ITS RESIDENTS. I VIEW THE JOB OF THE BOARD IS A SAFEGUARD FOR THE UNIQUE CHARACTER THAT'S SCOTTSDALE. WITH EACH DECISION IT MAKES THE MEMBERS OF THE BOARD NEED TO KEEP IN MIND HOW ITS DECISIONS SHAPE THE

NEIGHBORHOODS AFFECTED AND YES, THE LARGER COMMUNITY. WHILE MANY DECISIONS INVOLVED SMALL CHANGES TO LAND USE, I BELIEVE THAT THE CUMULATIVE EFFECT OF THE BOARD'S DECISIONS OVER TIME ARE SIGNIFICANT. THEY DETERMINE NEIGHBORHOOD BY NEIGHBORHOOD WILL LOOK AND FEEL OF OUR COMMUNITY. IF SELECTED, IN MAKING MY DETERMINATIONS I WILL BE GUARDED BY THE LEGAL REQUIREMENT THAT STRONGLY EMBODIES THAT CONCERN. AS A LITIGATOR I AM COMFORTABLE WITH EVALUATING EVIDENCE AND ASKING THE HARD QUESTIONS TO MAKE SURE THAT THE APPLICATION WILL IN FACT MEET ALL THE REQUIREMENTS. I HAVE BEEN ASKING COURTS AND JURIES TO DO JUST THAT FOR 35 YEARS SO I AM AWARE OF HOW THE PROCESS WORKS. I THINK THE BIGGEST CHALLENGE FACING THE BOARD WILL BE TO CONTINUE TO MAKE THE HARD DECISIONS THAT ARE IN THE BEST INTERESTS OF THE COMMUNITY AND IN COMPLIANCE WITH THE REQUIREMENTS. TO DO THAT I BELIEVE THAT THE BOARD WILL NEED PEOPLE WHO HAVE NO OTHER INTERESTS BUT TO ADHERE TO THE LAW GIVING DUE REGARD TO THE BEST INTEREST OF SCOTTSDALE. I COME HERE TODAY VOLUNTEERING TO SERVE NO OTHER REASON THAN TO PARTICIPATE IN COMMUNITY LIFE. I HAVE NO AGENDA OTHER THAN THE BETTERMENT OF OUR COMMUNITY AND THE DESIRE TO HELP TO ABIDE BY THE LAW. IF I AM SELECTED I PROMISE TO SERVE WITH HONOR AND WITH AN UNDIVIDED DEDICATION TO THE LAW AND THE BETTERMENT OF WONDERFUL OF THIS CITY.

IN THIS TOWN, MCCORMICK RANCH WAS ACTUALLY A WORKING RANCH AND THE SCOTTSDALE AIRPORT WAS IN THE MIDDLE OF THE DESERT. SCOTTSDALE IS MUCH DIFFERENT TODAY. BACK EVEN IN THOSE DAYS, EVERYTHING THAT WAS BUILT WAS BUILT ON EMPTY GROUND. TODAY THERE IS GOING TO BE SOME UNIQUE CHALLENGES FOR THE BOARD OF ADJUSTMENT. THE BOARD OF ADJUSTMENT WILL BECOME A NECESSARY TOOL IN HELPING TO SAVE OUR PAST. FOLLOWING A WIND STORM A FEW YEARS AGO, AN ICONIC SIGN BUILT IN THE EARLY '60S WAS DESTROYED. THERE WAS A WOMAN IN A BATHING SUIT DIVING OFF A 60 FOOT MOTEL SIGN AND THE MOTEL WAS ADVERTISING A SWIMMING POOL. OVER \$100,000 WAS RAISED TO REBUILD THIS HISTORIC SIGN. UNDER THE CURRENT SIGN ORDINANCE, A BUILDING PERMIT COULD NOT BE ISSUED. ARIZONA REVISED STATUE TITLE 9, SECTION 462 HAS THE ANSWER. IT STATES IN PART, RELIEF MAYBE GIVEN BY THE BOARD OF THE ADJUSTMENT AND I QUOTE BECAUSE OF SPECIAL CIRCUMSTANCES THE ORDINANCE DEPRIVES SUCH PROPERTY OF PRIVLEGES ENJOYED BY OTHER PROPERTY OF THE SAME CLASSIFICATION. LAST WEEK THE SIGN WENT UP AND IT WAS TURNED ON. WHEN I FIRST SERVED, THERE WAS LITTLE CONCERN ABOUT PRESERVING SCOTTSDALE'S HISTORY. WE ARE TOO BUSY BUILDING A COMMUNITY. TODAY BILL ADLER IS BACK ASKING TO BE A MEMBER OF THE BOARD. HE POSSESS SUBSTANTIAL KNOWLEDGE OF THIS BOARD'S OPERATION, IN OTHER WORDS, I AM READY TO HIT THE STREET RUNNING. THANK YOU.

Stephen Hermann: MY NAME IS STEPHEN HERMANN, I HAVE BEEN A SCOTTSDALE RESIDENT FOR 42 YEAR, I MOVED HERE IN 1970. I WOULD LIKE TO REPAY THE CITY FOR WHAT IT HAS PROVIDED ME AND MY FAMILY. AFTER SEVEN YEARS WITH THE FIRE DEPARTMENT, I WENT TO WORK FOR THE STATE AND RETIRED AS THE HAZARDOUS MATERIALS COORDINATOR FOR THE ARIZONA DEPARTMENT OF PUBLIC SAFETY. DURING THOSE 25 YEARS I WROTE THE STATE HAZARDOUS MATERIALS RESPONSE PLANS AND THE DPS PERSONAL PROTECTIVE EQUIPMENT PLANS. I RESPONDED TO HUNDREDS OF CHEMICAL SPILLS OVER THE STATE. I WAS U.S. DOT'S NATIONAL CHAIRMAN FOR STATE AND MUNICIPAL ENFORCEMENT OFFICERS. THE U.S. EPA SELECTED ME TO SERVE ON A FEDERALLY CHARTERED CONGRESSIONAL ADVISORY BOARD. I FURTHER TESTIFIED ON SEVERAL U.S. CONGRESSIONAL SUBCOMMITTEES. BASED ON THESE EXPERIENCES, I HAVE WRITTEN OVER 125 ARTICLES IN EVERY MAJOR ENVIRONMENTAL, FIRE SCIENCE, AND LAW ENFORCEMENT PUBLICATION IN THE COUNTRY. WHILE PREVIOUSLY CONSULTING FOR THE STATE OF NEVADA'S CRITICAL INFRASTRUCTURE PROTECTION PROGRAM, I WROTE THEIR INFRASTRUCTURE LIAISON OFFICER PLAN. James Heitel: GOOD AFTERNOON MAYOR AND VICE MAYOR, COUNCIL THANK YOU VERY MUCH FOR HAVING ME. MY NAME IS JAMES HEITEL I LIVE AT 8485 EAST DIXILETA DRIVE IN SCOTTSDALE. I'M A THIRD GENERATION ARIZONAN AND I HAVE BEEN IN SCOTTSDALE FIFTEEN YEARS AT THAT ADDRESS. AS YOU ARE AWARE I AM THE CURRENT CHAIRMAN OF THE PRESERVE COMMISSION JUST HAVING BEEN RE ELECTED BY MY FELLOW COMMISSIONERS TO A SECOND TERM. SUCCESS AND A POSITIVE ACHIEVEMENT ARE IMPORTANT CRITERIA TODAY FOR CONSIDERATION AS THEY SHOULD BE. I AM PLEASED TO REPORT THAT WE HAVE A LOT OF THAT AT THIS COMMISSION. AND SO I AM HERE TODAY ASKING YOU TO SUPPORT MY REAPPOINTMENT TO CONTINUE WITH MY SUCCESSES. NOT LONG AGO MANY WERE SUGGESTING THAT IT WAS INCONCEIVABLE THAT THE PRESERVE VISION WOULD EVER BE REALIZED. HAPPILY AS WE EXCEED 30,000 ACRES THIS FALL, WE CAN SAY THEY WERE WRONG. ONE OF THE MAJOR ISSUES THAT PRESENTS ITSELF WITH THE LOCATION OF THE DESERT PRESERVE DISCOVERY CENTER AT THE GATEWAY IS THAT THE COMMISSION AND I BELIEVE THAT IF IT'S TO BE LOCATED THERE THE CITIZENS NEED TO APPROVE OF THAT LOCATION PER THE CITY ORDINANCE AND THE GENERAL CHARTER AND IF THE CITIZENS APPROVE THAT, THAT'S THEIR WISHES. AND, SO I BELIEVE THAT. WE ARE CONDUCTING HEARINGS NOW AND WE HAVE MADE RECOMMENDATION TO THE PHASE THREE COMMITTEE IN REGARD TO OTHER LOCATIONS BECAUSE IT'S INTERESTING IF YOU GO BACK TO THE 2010 CONSULTING STUDIES DONE BY THE PHASE TWO COMMITTEE WHEN THEY ASKED THE FOCUS GROUPS REGARDING THE ACCEPTABILITY OF THE GATEWAY LOCATION, LESS THAN 50% OF THE FOCUS GROUPS, PEOPLE RESPONDED THAT IT WAS AN ACCEPTABLE LOCATION. I BELIEVE CITIZENS WHO SPENT TIME, EFFORT, AND MONEY NEED TO BE APART OF THAT DECISION BY VOTING TO APPROVE THAT LOCATION OR NOT. THANK YOU.

Janice Friebaum: GOOD AFTERNOON, MY NAME IS JANICE FRIEBAUM. I'VE LIVED IN SCOTTSDALE FOR TWO YEARS, I DEEPLY APPRECIATE MCDOWELL PRESERVE. SINCE MOVING HERE 2 YEARS AGO, I HIKED MOST OF THE PRESERVE TRAILS AND I HAVE BECOME A MEMBER OF THE SONORAN DESERT WOMEN. IN A MINUTE I WILL DESCRIBE MY BACKGROUND AND NATURAL AREAS ACQUISITION. I HAVE CONSIDERABLE EXPERIENCE WITH ESABLISHING AND MANAGING NATURAL AREAS SUCH AS THE MCDOWELL SONORAN PRESERVE. I SINCERELY WANT TO BE HELPFUL. I BELIEVE MY PROFESSIONAL AND PERSONAL SKILLS CAN BE AN ASSET TO THE COMMISSION. IT'S IMPORTANT TO ME TO THINK GLOBALLY AND ACT LOCALLY AND TO MAKE ACONTRIBUTION TO THE COMMUNITY IN WHICH I LIVE. I HAVE AM UNDERGRADUATE DEGREE IN ENVIRONMENTAL SCIENCE. A GRADUATE DEGREE IN PLANT ECOLOGY. PROFESSIONALLY I'VE WORKED FOR THE FEDERAL, STATE AND COUNTY GOVERNMENT-AGENCIES IN A WIDE VARIETY OF POSITIONS, EVERYTHING FROM NATURAL AREAS MANAGER FOR THE STATE OF WASHINGTON, NATURAL AREAS MANAGER FOR THE STATE OF WASHINGTON, NATURAL AREAS CONSERVATION BIOLOGIST, OPEN SPACE ACQUISITION MANAGER, ENVIRONMENTAL PLANNER, NATIONAL PARK NATIONALIST. I PERSONALLY CONDUCTED RESEARCH AND BIOLOGICAL MONITORING IN NATURAL AREAS AND MONITORING PLANTS AND PRESENTED AT CONFERENCES AND PUBLIC ARTICLES AND PARTICIPATED IN STAFF AND BOARD COMMISSIONS FOR NATURAL AREAS. I HAVE A FEW WAR WOUNDS FROM THAT. I HAVE CONDUCTED PUBLIC MEETINGS FOR ACQUIRING LAND FOR DISCUSSING APPROPRIATE PUBLIC USES AND FOR CONDUCTING SENSITIVE SITE MANAGEMENT ACTIVITIES. ADDITIONALLY I WAS INVOLVED IN WASHINGTON STATE'S TIMBER, FISH AND WILDLLIFE CONSORTIUM THAT'S NOT AN EASY TASK. OUTSIDE OF THE ENVIRONMENTAL ARENA I SERVE ON THE ADVISORY BOARDS AND COMMITTEE OF THE AREAS OF SENIOR SERVICES, WORK FORCE DIVERSITY, AND PUBLIC TRANSPORTATION AND ADVOCACY FOR HOLOCAUST SURVIVORS. FINALLY AS TO MY ABILITY TO SEE THINGS FROM THE PUBLIC USER PERSPECTIVE, I'M AN AVID OUTDOOR ENTHUSIAST FOR MY ENTIRE LIFE: HIKING, BACKPACKING AND MUSHROOM HUNTING AND CROSS COUNTRY SKIING. THEREFORE THE PRIORITY ALWAYS NEEDS TO BE SECURING THE PARCELS OF LAND THAT MAKE A PRESERVE ECOLOGICALLY DEFENSIBLE AND SUITABLE FOR ITS PUBLIC USE GOALS. ACQUISITION NEEDS TO HAPPEN WHILE OPPORTUNITIES STILL EXIST. THEREFORE, I SAY THE TOP ISSUES FACING THE COMMISSION IS TO GARNER PUBLIC SUPPORT FOR THE LAST REMAINING PARCELS NEEDED TO ACHIEVE OF A LONG RANGE GOAL OF A 34, 000 RANGE PRESERVE. I WAS BORN AND RAISED IN TUCSON AND WE HAVE ALWAYS GIVEN BACK TO THE COMMUNITY ONE WAY OR ANOTHER AND JUST MAKING THE NEIGHBORHOOD AND THE ENVIRONMENT SAFER. OVER THE LAST HOLIDAY I THOUGHT TO MYSELF, I REALLY HAVE NOT BEEN DOING ANYTHING HERE IN THE CITY OF SCOTTSDALE AND I WAS READING THROUGH THE PAPER AND I SAW THE ADS FOR THE APPLICATION OF THE BOARD AND I AM LIKE YOU KNOW WHAT, THIS IS MY TIME, IT JUST FELT RIGHT TO DO IT. YOU KNOW AS FOR MY EXPERIENCE TO SIT ON THE BOARD, I THINK REALLY IS MY 16 YEARS OF LIVING HERE IN THE CITY AND SEEING THE GROWTH, SEEING THE CHANGE AND THE RECOVERY AS WELL, I REMEMBER GOING ON A RECRUITING TRIP TO SCOTTSDALE COMMUNITY COLLEGE FOOTBALL AND THE ROAD FOR DIRT, IT'S LIKE WOW, IT'S COMPLETELY CHANGED.
