WE VERY MUCH APPRECIATE YOU PARTICIPATING WITH US ON THIS. IT MADE THAT DECISION MORE DIFFICULT THAN IT MIGHT HAVE BEEN OTHERWISE. WE'RE GLAD TO HAVE MET YOU AND UNDERSTOOD YOUR POSITIONS WITH US HERE.
