HOWEVER, MY SCOTTSDALE ROOTS RUN A LOT DEEPER THAN THAT IN MY TWO CHILDREN HAVE BEEN EDUCATED AND HAVE LIVED WITHIN SCOTTSDALE SINCE 2002 AND I MANAGED A BUSINESS AT THE SCOTTSDALE AIRPORT SINCE 2011. I'M A GRADUATE OF THE UNIVERSITY OF NEBRASKA COLLEGE OF LAW AND UNIVERSITY OF SAN DIEGO WITH A BACHELOR'S IN BUSINESS ADMINISTRATION. I'D LIKE TO THANK YOU ALL FOR YOUR CONSIDERATION FOR THE VACANCY ON THE TRANSPORTATION COMMISSION AND AS I BELIEVE YOU ARE ALL AWARE, TRANSPORTATION IS A SUBJECT THAT IS NEAR AND DEAR TO ME. TRANSPORTATION IS THE LIFE BLOOD OF COMMERCE, BOTH INTO AND WITHIN OUR CITY, AND AT LEAST WITH REGARD TO AIR TRAVEL, TRANSPORTATION IS AN AREA THAT SO FAR I'VE CHOSEN TO DEDICATE MY CAREER TO PROMOTING AND IMPROVING. WE'RE ALSO ACTIVE PARTICIPANTS IN THE MARICOPA COUNTY TRIP REDUCTION PROGRAM, WHICH I BELIEVE PLAYS A KEY ENVIRONMENTAL AND TRAFFIC CALMING ROLE. I ALSO CURRENTLY SERVE AS THE FACILITATOR FOR THE TRANSPORTATION CENTERED SCOTTSDALE CHAMBER FOCUS INITIATIVE GROUP FOR IMPROVING ACCESS, AS WELL AS THE ELECTED VICE-PRESIDENT FOR THE ARIZONA BUSINESS AVIATION ASSOCIATION, WHICH IS A GROUP OF PROFESSIONALS DEDICATED TO PROMOTING BUSINESS AVIATION WITHIN THE STATE.
