WE HAVE ONE PRESENTATION THIS EVENING, AND AISLE I'D LIKE TO WELCOME THE VICE CHAIR OF THE ENVIRONMENTAL QUALITY ADVISORY BOARD, BILL SCHAEFFER, WHO IS HERE TO TALK ABOUT THE ENVIRONMENTAL AND ENERGY EFFICIENCY RECOGNITION PROGRAM. SO BILL.

Environmental Quality Advisory Board Vice Chair Bill Sheaffer: THANKS VERY MUCH MR. MAYOR AND COUNCILMEMBERS. WE APPRECIATE THE INTEREST, THE TIME AND THE COURTESY YOU'VE EXTENDED FOR US TO MAKE THIS PRESENTATION THIS EVENING. I WONDER IF DEREK. EARLE, WHO IS THE ACTING EXECUTIVE DIRECTOR OF PUBLIC WORKS, I'M NOT SURE HOW YOU GET THAT ON A BUSINESS CARD, BUT IF YOU AND MEL GALBRAITH COULD COME UP, AND WE WANT TO EMBARRASS YOU WITH A FEW KIND WORDS IN A MOMENT. EQAB HAS INTERACTED WITH MANY CITY DEPARTMENTS AND WE HAVE FOUND THAT SOME HAVE DEVELOPED EFFECTIVE AND IMPORTANT ACCOMPLISHMENTS THAT ARE DUE RECOGNITION. EQAB HAS A PASSION FOR MEASURABLE ACCOMPLISHMENTS AND RECOGNITION OF THOSE ACCOMPLISHMENTS. WE'RE ADDRESSING NOT JUST ENVIRONMENTAL ISSUES BUT WITH THESE DEPARTMENTS ISSUES OF FISCAL RESPONSIBILITY AS WELL. THE WORD SUSTAINABILITY GETS BANTERED AROUND QUITE A BIT. I THINK IN A WORD, IF YOU CAN'T AFFORD IT, IT'S NOT SUSTAINABLE. WE'RE ADDRESSING NOT JUST THE ENVIRONMENTAL ASPECT, BUT THOSE ASPECTS OF ECONOMIC SUCCESS. OUR PLAN IS TO PRESENT THEM WITH A PLAQUE AND THIS WOULD BE FOR THE DEPARTMENTS THAT WE DO RECOGNIZE DOWN THE ROAD, AT AN EVENT SUCH AS THIS, AND TO PROVIDE WRITTEN DOCUMENTATION THAT CAN BE PROVIDED FOR FUTURE PUBLICATION. THE CITY HAS PUT OUT AN ARTICLE USING THIS MATERIAL AND WE APPRECIATE THAT. THINKING OUT OF THE BOX, USING NEW TECHNOLOGY AND NOT CONTENT TO GO DOWN THAT SAME COMFORTABLE ROAD. ONE OF MY MENTORS ONCE ADVISED ME THE DIFFERENCE BETWEEN A RUT AND A GRAVE IS A MATTER OF DIMENSION. OUR GOAL IS THREE-FOLD: TO PROVIDE RECOGNITION, TO ENCOURAGE CONTINUED EFFORTS TOWARD THESE GOALS, AND TO INSPIRE OTHER DEPARTMENTS TO EXCEL IN

BOTH ENVIRONMENTAL AND FISCAL RESPONSIBILITY. SO EQAB IS PLEASED TO RECOGNIZE THE SCOTTSDALE FLEET DEPARTMENT. THEY'VE BEEN A LEADER IN FUELS AND CORRESPONDING REDUCTION IN EMISSIONS FOR OVER THIRTEEN YEARS. LAST YEAR ALONE THEY DISPLACED SOME 681,000-GALLONS OF FUEL. CORRESPONDING EMISSION REDUCTION, IF YOU CAN THINK OF IT IN TERMS THAT THEY KEPT FROM THE ATMOSPHERE. ONE PICK-UP TRUCK OF CO2 PER DAY AND THESE ARE COMMENDABLE ACCOMPLISHMENTS. THEY'VE HAVE REDUCED OUR DEPENDENCE ON FOREIGN OIL. WE HAVE NO OIL OR REFINERIES IN ARIZONA, SO ALL OF OUR FUEL HAS TO BE IMPORTED, IF YOU WILL. WE KEPT SOME 2 AND A HALF MILLION DOLLARS THAT WAS NOT SENT OVERSEAS. WE THINK SEND OUR MONEY TO THE MIDWEST RATHER THAN OVERSEAS. A SIMPLE MATTER OF REDUCTION BY PLACING A CHIP IN THE ENGINE SAVED 15-GALLONS OF FUEL JUST BY SHUTTING OFF THE ENGINE. THAT'S ABOUT \$55,000 IN SAVINGS PER YEAR. THE NEW VEHICLES THEY'RE BRINGING IN, THEY COST SOME MORE, BUT THE PAY OUT PERIOD IS ABOUT THREE AND A HALF YEARS. THIS MEANS COMING BACK TO THE CITY FOR THE REMAINING THREE AND A HALF YEARS OF THEIR PROJECTED LIFE IS ABOUT \$2 PER GALLON THAT'S COMING BACK AFTER THAT INVESTMENT. WE'D LIKE TO REVIEW A COUPLE OF NUMBERS. YOU HAVE THOSE. I WON'T GO THROUGH THEM IN DETAIL. THEY'RE RUNNING ABOUT 325 HEAVY DUTY VEHICLES ON BIO DIESEL. IT TAKES ABOUT 50 PERCENT OF THE POLLUTANTS OUT OF THE AIR. THE LIGHT DUTY VEHICLES ARE RUNNING ON ETHANOL. THEY'RE RUNNING ELECTRIC VEHICLES WHERE IT'S SHORT. WE'RE LOOKING AT THE POWER OF CHOICE AND THAT'S THE ABILITY THROUGH ALTERNATIVE FUELS TO TAILOR THE FUEL AND VEHICLE TO THE SPECIFIC NEEDS. WE'RE DELIGHTED TO MAKE THIS PRESENTATION AND WE APPRECIATE THE ATTENTION OF OUR CITY COUNCIL AND OUR MAYOR.

ONE OF THE THINGS I ASK PEOPLE THAT I INTERVIEW TO DO THE DUE DILIGENCE, I ASK QUESTIONS ABOUT, AND THEY'RE USUALLY ATTORNEYS, WHAT THEIR OPINIONS ARE OF SCOTTSDALE CITY COURT. I WANT TO KNOW IF IT'S DIFFERENT ATTORNEYS EVERY TIME I TALK TO THEM. THEY SAY SCOTTSDALE CITY COURTS IS ONE OF THE BEST IN THE VALLEY. YOU CAN HAVE GREAT JUDGES, BUT YOU CAN'T HAVE A GREAT COURT WITHOUT GREAT STAFF. I THINK THE CITY OF SCOTTSDALE COURT HAS DONE A GREAT JOB FOR OUR RESIDENTS HERE. JUDGE BLAKE, SUPERIOR SCORES IN THE PERFORMANCE SURVEYS. HE'S THE GO-TO JUDGE WHEN THE OTHERS HAVE LEGAL ISSUES TO DISCUSS. HE'S A WORKHORSE, ARRIVES EARLY AND LEAVES LATE. HE HANDLES MOST OF THE CASES OF ALL OF THE JUDGES AND IS ALWAYS AVAILABLE TO HANDLE MATTERS WHEN ANOTHER JUDGE CAN'T GET TO IT BECAUSE OF HIS OTHER CALENDER. HE'S A NO-NONSENSE KIND OF GUY. HE'S A KEY PLAYER AND HAS MADE OUR CITY COURT ONE WITH OF THE

BEST IN THE VALLEY. THE JAAB HAS RECOMMENDED THAT JUDGE BLAKE BE REAPPOINTED. IF THERE ARE ANY QUESTIONS, I WOULD BE HAPPY TO ADDRESS.

Mayor Lane: I WOULD OFFER THE OPPORTUNITY FOR JUDGE BLAKE TO SAY A FEW WORDS. WE'D BE HAPPY TO HEAR FROM HIM.

Don Alvarez: THANK YOU.

Judge Blake: MAYOR LANE, MEMBERS OF THE CITY COUNCIL, MY NAME IS JIM BLAKE. I HAVE SERVED THE CITIZENS OF SCOTTSDALE SINCE JANUARY OF 1984 WHEN I WAS SWORN AS THE DEPUTY COUNTY ATTORNEY. I MEET WITH MAYOR DRINKWATER TO ASSIST SCOTTSDALE WITH ANY ISSUES THEY HAD. I WAS APPOINTED THE DIVISION CHIEF TO RUN THE COUNTY ATTORNEY'S OFFICE IN THIS AREA AND I WORKED WITH VARIOUS COUNCILMEMBERS WHEN I WAS A COUNTY ATTORNEY AND IN 2001 JOINED THE SCOTTSDALE CITY COURT. I HIT RETIREMENT TWO YEARS AGO BUT HAVE NOT RETIRED, AND I WOULD LIKE TO CONTINUE SERVING THE CITIZENS OF SCOTTSDALE. I'D BE HAPPY TO ANSWER ANY QUESTIONS.

Mayor Lane: THANK YOU JUDGE. APPRECIATE YOUR PAST SERVICE AS WELL. I DON'T THERE THINK THERE'S ANY QUESTIONS OF YOU, BUT THANK FOR YOUR KIND REMARKS.

Councilman Robbins: MAYOR, I WOULD LIKE TO MAKE A MOTION TO REAPPOINT JUDGE BLAKE FOR A FOUR-YEAR TERM BEGINNING SEPTEMBER 8, 2013.

Councilwoman Milhaven: SECOND.

Mayor Lane: VERY GOOD. A MOTION HAS BEEN MADE TO CONTINUE AND SECONDED. SO THERE'S NO FURTHER COMMENTS, THEN WE'RE RED READY TO VOTE. IT'S UNANIMOUS JUDGE BLAKE TO CONTINUE YOUR TERM. SO THANK YOU.

Mayor Lane: THE NEXT ITEM OF BUSINESS IS ITEM FIVE, WHICH IS THE MAYOR AND CITY COUNCIL MISSION AND GOALS AND WE HAVE MR. STOCKWELL HERE FOR THE STRATEGIC INITIATIVES WE HAVE PRESENTED.

Assistant to the City Manager Brent Stockwell: THE PURPOSE OF TONIGHT'S AGENDA ITEM IS TO ACCOMPLISH TWO THINGS TONIGHT, REVIEW THE MISSION STATEMENT AND GET ANY DIRECTION ON ANY REVISIONS YOU DESIRE AND TO REVIEW THE PRIORITY AREAS. WE WILL OBTAIN PUBLIC FEEDBACK BY THE CITY COUNCIL AT A WORK/STUDY SESSION ON SEPTEMBER 17TH. THE IDENTIFICATION OF A MISSION STATEMENT AND PRIORITIES OR GOALS IS A CRITICAL PART OF ANY STRATEGIC PLANNING PROCESS. IT PROVIDES A METHOD FOR OBJECTIVES, INITIATIVES AND PERFORMANCE MEASURES. ONCE THE COUNCIL PROVIDES CLEAR DIRECTIONS ON THE MISSION AND

GOALS, STAFF CAN DEVELOP MEASURES CONSISTENT WITH THAT DIRECTION. LET'S TURN TO THE MISSION STATEMENT. IT STATES WHY THE ORGANIZATION EXISTS. A MISSION STATEMENT IS A BROAD, BUT CLEAR PURPOSE FOR THE ENTIRE ORGANIZATION. IT HELPS THE ORGANIZATION DECIDE WHAT TO DO AND WHAT IT SHOULD NOT BE DOING. ON THE SCREEN IS THE MISSION STATEMENT LAST AFFIRMED BY THE CITY COUNCIL IN NOVEMBER OF 2004. YOU CAN DECIDE TO ADOPT THE STATEMENT OR GIVE A NEW STATEMENT. A GOOD MISSION STATEMENT PROVIDES DIRECTIONS TO THE ORGANIZATION TO MAKE SURE IT DOES THE RIGHT THINGS. IT SHOULD BE CLEAR AND EASILY UNDERSTANDABLE, MEMORABLE AND EASILY MEMORIZABLE TO AID IN DAY-TO-DAY DECISION MAKING. AS THE CITY CONSIDERS WHETHER OR NOT TO MAKE CHANGES, THE EFFECTIVE MISSION STATEMENT IS SHORT AND FOCUSED AND SHOULD FIT ON A TEE SHIRT. IT FITS, BUT THE FONT SIZE IS PRETTY SMALL. THE BRIEF SLOGAN THE CITY USED PRIOR TO 2002. THIS IS A SLOGAN, NOT A MISSION STATEMENT. IT WAS USED BY THE ORGANIZATION TO GUIDE DAY-TO-DAY DECISION MAKING. I'VE LEFT THIS SHIRT BLANK SO YOU CAN THINK ABOUT WHAT YOU MIGHT LIKE TO CHANGE. IF A STATEMENT CANNOT BE EASILY REMEMBERED, IT LOSES EFFECTIVENESS AS A TOOL TO GUIDE THE ORGANIZATION. SOME OPTIONS WE'VE DEVELOPED ARE AGREE TO A NEW MISSION STATEMENT OR DIRECT STAFF TO WORK ON MORE OPTIONS AND RETURN BACK IN SEPTEMBER. WE'VE INCLUDED TWO OPTIONS IN THE CURRENT REPORT. PROMOTE AND PROTECT QUALITY OF LIFE. YOU CAN SEE WHERE THIS LANGUAGE APPEARS IN THE CURRENT STATEMENT. THESE OPTIONS KEEP SIX OR TWELVE OF THE WORDS FROM THE EXISTING MISSION STATEMENT AND REMOVE THE LANGUAGE THAT IS ALREADY COVERED IN THE GENERAL PLAN, WHICH COULD HELP MAKE THE STATEMENT BE MORE MEMORABLE AND MEMORIZABLE AS AN EXAMPLE. I'LL STOP HERE AND LET YOU DISCUSS IT.

Mayor Lane: THANK YOU MR. STOCKWELL. START WITH QUESTIONS OR COMMENTS BY COUNCILWOMAN MILHAVEN.

Councilwoman Milhaven: IF WE GO BACK TO THE T-SHIRTS, I THINK WE DO SCOTTSDALE SIMPLY BETTER. BUT ANY WAY, I WOULD ADVOCATE FOR A SHORTER MISSION STATEMENT, RATHER THAN THE LENGTHY ONE WE HAVE HERE AND SINCE WE HAVE A NEW CITY MANAGER, I THINK THE MISSION OF THE CITY SHOULD BE MORE THAN A COUNCIL DRIVEN MISSION. I'D LIKE TO HAVE THE NEW CITY MANAGER WORK WITH STAFF TO COME BACK WITH A RECOMMENDATION IN SEPTEMBER ON A MISSION STATEMENT THAT STAFF AND COUNCIL COULD EMBRACE WITH THE DIRECTION THAT LESS IS MORE.

Mayor Lane: THANK YOU COUNCILWOMAN. COUNCILMAN ROBBINS.

Councilman Robbins: SO BRENT, WHOSE MISSION STATEMENT ARE WE TRYING TO FULFILL, IS IT THE COUNCIL'S MISSION STATEMENT, THE ORGANIZATION, THE EMPLOYEES OF SCOTTSDALE, OR OUR COMMUNITY'S MISSION STATEMENT, BECAUSE IT DEPENDS UPON MY PERSPECTIVE AND WHOSE MISSION STATEMENT I'M TRYING TO PROMOTE, I COULD COME UP WITH A DIFFERENT ANSWERS TO EACH OF THOSE SCENARIOS. WHAT ARE YOU TRYING TO HAVE US ANSWER?

Brent Stockwell: GOOD QUESTION. I THINK WHAT WE'RE TALKING ABOUT HERE IS THE ORGANIZATION'S MISSION STATEMENT, THE CITY OF SCOTTSDALE ORGANIZATION. IT'S A GENERAL

PLAN WHICH TALKS ABOUT THE COMMUNITY'S VISION, SO THIS IS THE ORGANIZATION AS CONTRASTING THE COMMUNITY AS A WHOLE.

Councilman Robbins: SO I REMEMBER THE SIMPLY BETTER SERVICE AND I WROTE DOWN SIMPLIFY WHEN I WAS READING THIS MATERIAL AND THE MIDDLE ONE LOOKS LIKE A CITY COUNCIL DRIVING POLICY STATEMENT, BUT THE 1999 TO 2000 LOOKS LIKE AN ORGANIZATIONAL STATEMENT. SO YOU HAVE TWO DIFFERENT MISSION STATEMENTS, DEPENDING ON WHICH PERSON OR GROUP YOU'RE ASKING. IF YOU'RE ASKING FOR A MISSION STATEMENT OF THE ORGANIZATION I THINK THAT WOULD COME UP FROM THE ORGANIZATION, AND ARE YOU ASKING FOR AN ENDORSEMENT OF THAT, IS THAT WHAT YOU'RE ASKING FOR US TO ENDORSE, AN ORGANIZATIONAL MISSION STATEMENT.

Brent Stockwell: THE CITY COUNCIL SITS IN A UNIQUE POSITION. IT'S THE BRIDGE BETWEEN THE ORGANIZATION AND THE CITIZENS THAT THE ORGANIZATION SERVES. YOUR FEEDBACK ON WHAT YOU WANT THIS ORGANIZATION TO LOOK LIKE IS PARAMOUNT. THE MISSION STATEMENT SHOULD PROVIDE CLEAR DIRECTION TO THE ORGANIZATION, HOWEVER YOU SEE SOME ORGANIZATIONS DO THEM IN DIFFERENT WAYS. SOME HAVE THEM COME UP THROUGH THE ORGANIZATION AND IT COMES UP TO WHAT DOES THIS BODY WANT? IF YOU WANT US TO GO BACK AND DEVELOP THAT AND COME BACK IN SEPTEMBER, WE CAN DO THAT. IF YOU WANT TO CONTINUE WITH THE CURRENT STATEMENT, YOU'RE ABSOLUTELY RIGHT, THAT CAME OUT IN 2000. THAT LANGUAGE IS EMBEDDED IN THAT GENERAL PLAN SO IT'S ALREADY THERE AS AUTHORITATIVE GUIDANCE FOR THE ORGANIZATION. THE QUESTION IS DO YOU WANT TO PROVIDE SOME CLEARER CONCISE DIRECTION THAT HELPS SHAPE THE ORGANIZATION THE WAY YOU THE COUNCIL WANT TO DO THAT. IT WAS DECIDED IN THE 2000 TIME FRAME THEY WANTED TO GO IN A DIFFERENT DIRECTION. DIFFERENT TIMES, DIFFERENT COUNCILS WANT TO GO IN DIFFERENT DIRECTIONS.

Councilman Robbins: RIGHT, AND I THINK THAT'S GOOD AND I AGREE, I THINK WE SHOULD GO BACK TO MORE OF A SLOGAN. WHEN YOU LOOK AT ADVERTISING, YOU KNOW JUST DO IT, OR COKE ENJOY LIFE, AND THEN UNDERNEATH THAT THEY HAVE WE'RE GOING TO DO THESE THINGS TO MAKE SURE WE PROMOTE OUR BRANDS, SO I THINK THIS SHOULD BUBBLE UP FROM WHAT THE EMPLOYEES SEE AND WE HAVE A GOOD OPPORTUNITY WITH A FRESH PERSPECTIVE ON A NEW CITY MANAGER THAT WE SHOULD HAVE THAT COME BACK. IT SHOULD CIRCULATE AND WORK ITS WAY THROUGH THE ORGANIZATION AND COME BACK TO US AND WE CAN WORK TOGETHER ON THAT. THANK YOU.

Mayor Lane: THANK YOU COUNCILMAN. COUNCILWOMAN KORTE.

Councilmember Korte: AGAIN, THE WHOLE KISS PHILOSOPHY OF KEEP IT SIMPLE STUPID APPLIES HERE. IT SHOULD FIT ON A TEE SHIRT AND BE VERY SHORT AND POIGNANT AND MEMORABLE AND MEMORIZABLE. NOT ONLY DO WE HAVE A NEW CITY MANAGER, WE HAVE A NEW HR DIRECTOR TOO, WE HAVE A NEW ECONOMIC DEVELOPMENT DIRECTOR AND TRANSPORTATION DIRECTOR ALL SITTING HERE AND I KNOW THEY'RE VERY SKILLED IN THEIR OWNER WORK, BUT ALSO VERY COMMITTED TO SCOTTSDALE AS AN ORGANIZATION AND MOVING US FORWARD, SO IT MAKES SENSE TO COME BACK IN SEPTEMBER WITH A KEEP IT SIMPLE, STUPID.

Mayor Lane: THANK YOU COUNCILWOMAN. THAT COULD BE THE MISSION RIGHT THERE. IT FITS ON A TEE SHIRT. I WAS GOING TO SAY, I SUPPOSE IT'S JUST AN ADD TO SOME OF THE COMMENTS THAT'S BEEN MADE PREVIOUSLY AND THAT'S WHAT KIND OF MISSION STATEMENT ARE WE'RE TALKING ABOUT HERE. CERTAINLY THERE'S INPUT FROM THE ORGANIZATION ON THIS. AS YOU POINTED OUT, IT'S THIS BODY'S OBLIGATION TO MAKE THE CONNECTION BETWEEN THE COMMUNITY AND THIS TYPE OF ORGANIZATION MISSION STATEMENT AND IT IS DIFFERENT FROM STRATEGIC MISSION STATEMENT AND GENERAL PLAN MISSION STATEMENT AND THOSE KINDS OF THINGS. I THINK THIS IS AN OPTIONAL ONE. I THINK MISSION STATEMENT, IT'S VERY IMPORTANT. WE ARE AN ORGANIZATION, A SERVICE ORGANIZATION, SO OUR FOCUS NEEDS TO BE ON PROVIDING THOSE SERVICES ALL ACROSS THE BOARD. I THINK COMING BACK IN SEPTEMBER WITH A KISS KIND OF DIRECTION ON IT, BUT ALSO WITH THE IDEA OF GETTING DIRECTION FROM A SIMPLE MISSION STATEMENT. SOMETHING THAT'S EASY TO MEMORIZE OR THINK ABOUT EVERY TIME WE TAKE AN ACTION WITH REGARD TO THE SERVICES THEY PROVIDE IN THE ORGANIZATION. COUNCILMAN LITTLEFIELD.

Councilman Littlefield: I'M GOING TO MAKE THE SAME POINT I MADE AT THE VISIONING SESSION. WE HAVE A PERFECTLY GOOD DOCUMENT, WHICH TELLS WHAT OUR MISSIONS AND GOALS ARE AND IT'S THE VOTER APPROVED GENERAL PLAN, WHICH IS NOT ONLY MANDATED BY STATE LAW, BUT IT'S THE ONLY DOCUMENT THAT'S BEEN VOTED ON AND APPROVED BY THE VOTERS. THE VOTERS HAVE TOLD US WHAT THEY WANT TO DO, WE REALLY DON'T NEED TO GO THROUGH ANOTHER EXERCISE.

Mayor Lane: THANK YOU COUNCILMAN. COUNCILWOMAN MILHAVEN.

Councilwoman Milhaven: I JUST WANTED TO RESPOND, MR. STOCKWELL, YOU SAY YOU WERE LOOKING FOR MORE DIRECTION AND I KNOW ON PAGE 7, THIS VERY LONG MISSION STATEMENT WAS, WE DID REVIEW THIS AND I THINK GENERALLY, IF I RECALL A CONVERSATION EVERYBODY AGREED, SO I THINK STAFF UNDERSTANDS OUR MORE COMPLICATED VIEW OF THIS, WE'RE ASKING STAFF TO JOIN US IN THIS DIALOGUE. I THINK WE HAVE GIVEN YOU A LITTLE BIT OF DIRECTION ON WHERE WE'D LIKE TO SEE IT GO. THANK YOU. AND KEEP IT SIMPLE AND SPECIAL.

Mayor Lane: VERY GOOD. I CERTAINLY WOULD AGREE TOO COUNCILWOMAN. VICE MAYOR KLAPP.

Vice Mayor Klapp: AS BEEN STATED, I THINK WE NEED TO SIMPLIFY ALL THE WORDS IN THIS LARGE PARAGRAPH INTO SOMETHING THAT SAYS IT, BUT IN A FEW WORDS. YOU WERE KIND ON THE RIGHT TRACK WHEN YOU HAD THE SUGGESTED ALTERNATIVES UP THERE, PROMOTE AND PROTECT QUALITY OF LIFE. SOME OF THOSE WORDS ARE APPROPRIATE IN SOME KIND OF MISSION STATEMENT. I DON'T KNOW HOW MANY WORDS ARE APPROPRIATE FOR A TEE SHIRT, BUT QUALITY OF LIFE DEALS WITH PRIMARILY OUR CITIZENS, BUT SOMEWHERE IN THE MISSION STATEMENT, IT WOULD BE NICE TO WORK IN THE TOURISM EXPERIENCE AS WELL. BEYOND THAT, I THINK IT WAS STATED ORIGINALLY THAT SINCE WE HAVE A NEW CITY MANAGER, I BELIEVE IT'S IMPORTANT WE GET ADVICE FROM HIM ABOUT WHAT THE MISSION STATEMENT SHOULD BE AND LOOK AT THAT. SOMETHING SHORTER IS DEFINITELY WHAT ALL OF US ARE LOOKING FOR. Mayor Lane: THANK YOU VICE MAYOR. MR. STOCKWELL, I THINK WE'VE SPENT ON THAT.

Brent Stockwell: I THINK WE HAVE THE DIRECTION TO KEEP IT SIMPLE. ONE THING I'D LIKE TO MENTION THOUGH IS THAT THE MISSION STATEMENT INCLUDED IN THE GENERAL PLAN IS THE MISSION STATEMENT THAT THE 2000 MAYOR AND CITY COUNCIL CAME UP AND THE MONTH AFTER THAT, THEY VOTED ON IT AND CAME UP WITH WHAT CAME UP IN THE GENERAL PLAN. AS THE UPDATE PROCESS GOES FORWARD, IF THERE'S ANYTHING THAT THIS COUNCIL WOULD LIKE TO CHANGE AND GET THAT IN THE GENERAL PLAN, JUST BE CONSISTENT THAT 13, 14 YEARS HAVE PASSED SINCE THE LAST COUNCIL HAS DONE THAT. IF WE'RE READY TO MOVE ON TO THE GOALS, I CAN DO THAT. WE'LL IDENTIFY GOALS. IT'S RECOMMENDED THAT GOVERNMENTS AGREE ON FIVE OR FEWER GOALS THAT ADDRESS THE MOST CRITICAL ISSUES OF THE COMMUNITY. IT MAY BE NECESSARY TO DEFINE PRIORITIES AMONG THE GOALS. HERE ARE CRITERIA FOR GOALS. GOALS MAKE IT CLEARER SO YOU CONCENTRATE RESOURCES FOR RESULTS, THE MARK OF AN ORGANIZATION SERIOUS ABOUT SUCCESS. THESE GOALS HAVE BEEN LONG TERM GOALS TO IDENTIFY KEY OBJECTIVES AND FOR REPORTING PURPOSES. THESE GOALS ARE THE SAME AS THE CHAPTER HEADINGS IN THE PLAN, ALL 93 GOALS CASCADE FROM THESE SIX GOALS. THESE AREN'T GOING AWAY. IN ADDITION TO THOSE LONG TERM GOALS, IT'S IMPORTANT FOR THE COUNCIL TO CONSIDER SETTING SHORT-TERM GOALS, THAT ADDRESS THE MOST CRITICAL ISSUES CURRENTLY FACING THE COMMUNITY, THINGS THAT CAN BE PRIMARILY ACHIEVED OVER THE NEXT YEAR. AT THE MAY STRATEGIC WORKSHOP THE MAYOR AND COUNCIL IDENTIFIED EIGHT PRIORITY AREAS TO CONSIDER. THESE ARE LISTED ON THE SCREEN IN THE ORDER THEY WERE IDENTIFIED ON MAY 8TH. THEY'RE INCLUDED IN YOUR COUNCIL REPORT AS AN ATTACHMENT. WE WANT TO FIND OUT IF ANY PRIORITIES SHOULD BE ADDED TO THE LIST. CONFIRM THEY'RE IN THE PRIORITY ORDER YOU WANT US TO WORK ON AND ANY ADDITIONAL FEEDBACK YOU HAVE ON THESE ITEMS. Mayor Lane: THANK YOU. I WOULD SAY NUMBER ONE, WE WENT THROUGH A RATHER EXTENSIVE PROCESS TO COME UP WITH THIS LIST, AND AS A RESULT BY CONSENSUS AND CALCULATIONS, THESE WERE THE ITEMS IN THE PRIORITY LISTING AS THEY ARE. INTERESTINGLY ENOUGH, I THINK SOME OF THEM WOULD BE DIFFICULT BECAUSE OF THE DIFFERENT NATURE OF THE PARTICULAR GOALS, BUT I WOULD SAY BY LACK OF ANY ADDITIONAL INPUT ON THIS, THIS IS WHAT WAS CALCULATED THROUGH AND WE'RE FINE WITH THIS. Vice Mayor Klapp: SOME OF THESE ARE INTER-RELATED. IF YOU'RE LOOKING FOR FIVE OR SO PRIORITIES, I'M NOT SURE HOW WE WOULD WORD IT. TWO AND FOUR ARE RELATED. I BELIEVE THAT, WHERE'S THE OTHER ONE HERE I WAS LOOKING AT. AS WELL AS THE ECONOMIC DEVELOPMENT STRATEGY, IS THERE A WAY TO COMBINE THESE IN SOME WAY SO WE DON'T HAVE EIGHT SEPARATE AREAS, SO WE FOCUS IT MORE IN COMBINING THE GOALS TOGETHER BECAUSE THEY SEEM TO BE SIMILAR. Brent Stockwell: ONE THING WE COULD DO IS AS WE DEVELOP THE TEAMS AND LEADERS THAT ARE GOING TO DEVELOP THESE ACTION PLANS, WE COULD WORD THEM A LITTLE MORE CLEARLY AND OUTLINE THE ACTION STEPS, THAT WOULD BE FINE WITH THE COUNCIL AS LONG AS WE'RE CAPTURING THESE EIGHT PRIORITIES WITHIN THAT.

Mayor Lane: THANK YOU VICE MAYOR. COUNCILWOMAN KORTE.

Councilmember Korte: THANK YOU MAYOR. I ASSUME THAT ACTION PLAN WILL ALSO HAVE A TIME LINE WITH IT. I KNOW THERE WERE SOME CONVERSATION AROUND THESE SHORT-TERM GOALS AND PERHAPS A CITY COUNCILMEMBER HAVE ATTACHED TO EACH OF THOSE GOALS AND BE APART OF THAT PROCESS. I DON'T' KNOW IF THEY WOULD LIKE ANY DISCUSSION AROUND THAT.

Mayor Lane: WELL, LET'S SEE IF IT GENERATES SOME CONVERSATION. WE HAD SOMETHING POP UP ON THE SCREEN. COUNCILMAN LITTLEFIELD.

Councilman Littlefield: WHO WANTS TO ATTACH THEIR NAME TO GETTING MCDOWELL CORRIDOR ON THE RIGHT TRACK. ARE YOU VOLUNTEERING?

Councilmember Korte: I'VE BEEN DOING IT FOR THE LAST 20 YEARS.

Councilman Littlefield: PEOPLE ON TV THAT WERE WATCHING US, HASN'T IT BEEN A GOAL FOR AT LEAST 20 YEARS. WHAT HAVE YOU DONE AND WHAT'S THE PLAN? IF WE'RE JUST GETTING AROUND TO THAT NOW, AT LEAST 11 YEARS I'VE BEEN ON THE COUNCIL, PEOPLE HAVE TALKED ABOUT WE HAVE TO FIX THE MCDOWELL CORRIDOR. MOST OF THE CITIZENS INVOLVED WOULD SAY THEY HAVEN'T SEEN A LOT OF ACTION ON THAT. I WILL GO BACK, I HAD THIS CRITICISM IN THE MAY SESSION. IT'S ALL TALK. GET IT ON THE RIGHT TRACK. THAT'S A CLASSIC EXAMPLE. WE'VE BEEN TALKING ABOUT THAT FOR YEARS. DECIDING WHERE THAT'S A GOAL OR NOT. NO, WHO'S GOT A PLAN? THIS WHOLE PROCESS JUST SEEMS LIKE IT'S A WASTE OF TIME TO ME. IT JUST SEEMS LIKE IDLE TALK.

Mayor Lane: THANK YOU COUNCILMAN. I THINK THERE'S A COUPLE OF COMMENTS NOW WE'VE HAD ADDITIONAL DIALOGUE ON THIS. HOW DO WE KEEP OUR ECONOMIC ENGINES SUPPORTING A GREAT CITY AND I THINK THERE ARE SOME THINGS THAT COULD BE COMBINED HERE AND I AGREE WITH THE VICE MAYOR. WE SHOULD LOOK AT IT AND GET MORE CONCENTRATION ON IT. AS FAR AS THE NUMBER ONE ITEM THERE, GETTING THE MCDOWELL CORRIDOR ON THE RIGHT TRACK, IT'S ASSUMING IT'S ON THE WRONG TRACK AND ASSUMING THAT NOTHING HAS HAPPENED THERE. THAT'S NOT EXACTLY RIGHT. FRANKLY THERE ARE SOME THINGS THAT ARE GOING ON THERE, AND I THINK REFINING THAT, BUT I'M NOT HERE TO REWORK WHAT WE'VE ALREADY DECIDED ON. I THINK THAT'S SOMETHING WE WANT TO STAY AWAY FROM. WE AGREED ON THIS. IT TOOK US THE BETTER PART OF A FULL DAY TO DO THIS. I DON'T WANT TO REWORK IT. I DON'T BELIEVE ANYONE WANTS TO DO THIS. I WOULD SAY IF WE COULD BRING THIS DOWN, I WOULD AGREE TO FIVE ITEMS, IN SOME ITEMS CLOSELY RELATED, THAT WOULD BE WORTH WHILE. PART OF THIS PROCESS IS AN ACTION PLAN, SOMETHING WE'VE BEEN DOING WITHOUT THIS LIST, BUT NEVERTHELESS OF CONNECTING THE DOTS OF HOW WE GO ABOUT THIS. I WOULD SAY CONSOLIDATING DOWN TO FIVE ITEMS IS A GOOD ITEM AND THERE'S SOME ROOM FOR THAT AND SOME OF THIS IS GOING TO BE A COMMUNICATION OF WHAT TRACK WE'RE ACTUALLY ON AND THAT'S BEEN MAYBE A LITTLE BIT LACKING. VICE MAYOR.

Vice Mayor Klapp: FOR THE BENEFIT OF THE PEOPLE WHO WEREN'T IN THAT SESSION, IT WAS A VALUABLE PROCESS. THERE WERE MANY ITEMS THAT WERE ELIMINATED FROM THE LIST, SO THE VALUE OF THIS IN MY ESTIMATION IS WE BELIEVE THESE ARE THE MOST IMPORTANT THINGS THAT NEED TO BE WORKED ON. WE'RE NOT SAYING A LOT OF WORK HASN'T BEEN DONE IN THE PAST OR NOTHING IS BEING DONE RIGHT NOW, BUT WE AS THE COUNCIL BELIEVE THAT YOU OF THE CITY PEOPLE SHOULD BE TAKING THESE INTO CONSIDERATION FOR YOUR WORK PLAN AND TELLING US HOW WE'RE GOING TO DEAL WITH THOSE PARTICULAR ISSUES. THAT'S WHAT WE WANTED TO GET OUT OF THIS. I KNOW IT'S UNCOMFORTABLE TO BOIL IT DOWN TO EIGHT THINGS. IT'S IMPORTANT THAT WE GIVE SOME GUIDANCE TO ALL OF YOU SO THAT YOU UNDERSTAND WHAT'S MOST IMPORTANT TO US, SO YOU DON'T SPIN YOUR WHEELS ON SOMETHING THAT WHEN YOU BRING IT TO US AND SAY, WHO CARES, WHY HAVE YOU BEEN DOING? THIS IS A GOOD START OF A CONVERSATION WE HAVEN'T HAD ABOUT WHAT'S IMPORTANT TO THE COUNCIL, WHAT DO WE WANT TO GET DONE AND WHAT DIRECTION WE WANT TO GO. IT'S IMPORTANT NOT ONLY WITH THE MISSION STATEMENT, WITH THESE PRIORITIES THAT YOU COME BACK TO US AND START SKINNING SOME MEAT OFF THE BONES. WHAT'S THE MEAT FOR THOSE, WHAT DO YOU FEEL CAN BE DONE AND WE CAN HAVE A CONVERSATION ABOUT THAT AND DO WE FEEL THAT'S A GOOD APPROACH FOR MAKING THINGS HAPPEN. FOR EXAMPLE, ITEM ONE. I DON'T KNOW IF YOUR PRESENTATION IS GOING TO GET TO THE AREAS. ITEM ONE, DO WE WANT TO ACQUIRE PART OF PAPAGO PARK? WELL, IF EVERYBODY THINKS THE MCDOWELL CORRIDOR NEEDS HELP, THAT ITEM SHOULD BE CONSIDERED. IT WOULD INCREASE OUR FOCUS FOR A PARK IN THAT AREA. IS THAT IMPORTANT FOR THIS COUNCIL? I'M TRYING TO MAKE SURE THERE'S SOME UNDERSTANDING FOR THE AUDIENCE, WE SPENT A LOT OF TIME DISCUSSING IT AND WE CAME UP WITH A LIST THAT'S IMPORTANT TO US AND WE SHOULD BE USING IT AS A GUIDELINE FOR THE WORK THAT'S GOING TO BE ACCOMPLISHED OVER THE NEXT TWO YEARS. AND AFTER TWO YEARS, WE WOULD HAVE TO LOOK AT IT AND SEE WHAT WE COULD DO BETTER OR ACCOMPLISH AND WHAT WE COULD ELIMINATE. IT'S BETTER THAN WHAT WE'VE DONE IN THE PAST. WE WANT TO HAVE A GUIDELINE SO WE DON'T HAVE EVERYONE IN THE CITY GOING OFF IN 10, 20, 30 DIRECTIONS. IT'S A GREAT PROCESS AND I APPRECIATE THE CONVERSATIONS WE HAD TO COME UP WITH THIS LIST.

Mayor Lane: THANK YOU VICE MAYOR. COUNCILMAN ROBBINS.

Councilman Robbins: THANK YOU MAYOR. I COMPLETELY AGREE WITH THAT. ONE OF THE FRUSTRATING THINGS ABOUT THIS JOB IS WE REACT AN AGENDA THAT'S COMING AT US AND NOT BEING PROACTIVE. THIS IS A PROACTIVE THING WE'RE DEALING WITH. I'LL USE THE PHRASE, IF YOU FAIL TO PLAN, YOU PLAN TO FAIL. YOU CAN'T JUST SAY THIS IS BAD, I DON'T WANT TO TALK ABOUT THIS, THESE ISSUES DON'T MEAN ANYTHING, BECAUSE THEY REALLY DO. WE'RE ELECTED TO BECOME LEADERS TO LEAD. YOU HAVE ELECTIONS SO YOU CAN DECIDE WHO YOUR LEADERS ARE AND THEY GET TOGETHER AND SAY THIS IS WHERE WE'RE GOING. YOU HAVE STAFF LOOKING FOR THAT LEADERSHIP AS WELL. IT WASN'T ATTENDED BY VERY MANY CITIZENS, BUT IT WAS BY STAFF BECAUSE THEY'RE CURIOUS OF WHERE WE'RE COMING FROM AND THEY DON'T WANT TO WASTE TIME AND

RESOURCES. I APPLAUD THIS AND LOOK FORWARD TO THE RESULTS. I AGREE WITH THE VICE MAYOR, TOO OFTEN WE REACT AND DON'T PLAN, AND I THINK THIS IS POSITIVE.

Mayor Lane: THANK YOU COUNCILMAN. THESE ARE STRICTLY STRATEGIC GOALS. WE CAN CONSOLIDATE THIS TO FIVE, BUT WE'RE TALKING ABOUT STAFF COMING UP WITH TACTICS, HOW WE GO ABOUT ADDRESSING THOSE ISSUES AND BRINGING THEM BACK TO US. IT SOUNDS SIMPLE, I KNOW IT'S NOT, BUT THAT'S THE GOAL WE'RE TRYING TO ACCOMPLISH HERE. GIVE THE DIRECTION OF STRATEGIC GOALS AND MOVE ON FROM THERE. IF YOU LOOK AT THAT LIST QUICKLY, THOSE ARE THINGS WE HAVE CONCENTRATED ON. WE HAVE COLLECTIVELY FOUND ALL OF THEM TO BE IMPORTANT OVER THE LAST SEVERAL YEARS. I HAVE NO FURTHER COMMENTS ON THAT ONE. I HOPE YOU HAVE GUIDANCE ON THAT. THANK YOU, BRENT. ALL RIGHT. UNLESS WE HAVE ANY FURTHER COMMENT CARDS ARE PETITIONS, WHICH I PRESUME NOT SINCE THEY HAVEN'T BEEN DELIVERED.
