- Mayor Lane suggested selling underutilized equipment and putting the funds into the Capital Fund, rather than the General Fund.
- Mayor Lane suggested reviewing City memberships for each department.
- Mayor Lane asked to have each engineering contract considered individually to provide for opportunities to trim expenditures.
- Councilwoman Klapp suggested redesigning the large lobby area in the One Civic Center building to incorporate more office space.
- Councilwoman Klapp suggested reducing the fleet by 50 percent, instead of the proposed 25 percent.
- Councilwoman Klapp asked staff to look into the possibility of reducing the bulk trash collection schedule.
- Councilman Robbins suggested eliminating executive physicals.
- Mayor Lane stressed the importance of making structural changes to the budget.

• Jim Hill, Police Officers of Scottsdale Association, commented on funding a competitive compensation scale for the Police Department.

City Manager Fritz Behring gave a PowerPoint presentation (attached) on the City's proposed Fiscal Year 2014/15 Capital Improvement Plan (CIP) budget.

- Mayor Lane suggested adjusting transportation capital project money over time to be more engaged with project orientation, rather than administration.
- Vice Mayor Korte asked for a review of all programs as part of the budget process.
- Councilwoman Klapp suggested creating a policy that requires a certain percentage of the unreserved fund balance to go into the CIP each year.
- Councilman Phillips suggested allocating any unreserved fund balance to a specific use.
- Councilwoman Milhaven suggested eliminating positions that have been unfilled for more than 90 days.
- Councilwoman Milhaven asked that project plans be reviewed so they meet needs, are more cost efficient, and a better value.
- Vice Mayor Korte suggested that the public art improvements at WestWorld come from the public art program.
- Councilwoman Milhaven asked staff to review all of the salary ranges.
- Councilwoman Milhaven suggested listing each department's full-time employees in the budget book, rather than in an appendix.
- Councilman Littlefield does not believe any program should be considered untouchable, including the Cultural Council's \$4.5M contract.

WE, DAWN BROKAW AND SUSAN WHEELER, AS RESIDENTS OF THE CITY OF SCOTTSDALE, STATE OF ARIZONA, COUNTY OF MARICOPA, DO HEREBY PETITION THE COUNCIL OF SCOTTSDALE AS FOLLOWS.

WHEREAS, THE CURRENT OUTDOOR LIGHTING ORDINANCE, SECTION 7.600 WAS ADOPTED 30 YEARS AGO IN 1984, AND

WHEREAS, IN THE 30 YEARS SINCE IT WAS ADOPTED, LIGHTING TECHNOLOGY HAS CHANGED SIGNIFICANTLY, AND

WHEREAS, OUTDOOR LIGHTING TODAY PRODUCES MORE LIGHT OUTPUT, I.E.LUMENS AT LESS WATTAGE,

WHEREAS, OUR CURRENT ORDINANCE RELIES ON WATTAGE AND NOT LUMENS AS THE UNIT OF MEASURE, AND

WHEREAS, LIGHTING INTENSITY IS MORE IMPORTANT IN RURAL AND LOW DENSITY NEIGHBORHOODS, AND

WHEREAS, THE AMOUNT OF LIGHT OUPUT I.E. LUMENS, ALLOWED TODAY UNDER THE CURRENT ORDINANCE COULD NOT HAVE OCCURRED 30 YEARS AGO, AND

WHEREAS, THE CURRENT OUTDOOR LIGHTING ORDINANCE IS WELL OUTDATED, AND

WHEREAS, SOME OF THESE ISSUES HAVE ALREADY BEEN ADDRESSED IN GUIDELINES IN THE DESIGN STANDARDS AND POLICY MANUAL, AND

Citizen's Petition to Remove Loren Molever from the General Plan Task Force 2014 FEB -4 PM 5: 19

Scottsdale's General Plan is the second most important document in Scottsdale city government; it is second only to the organic law of the City, which is the City Charter. The General Plan is Scottsdale's master policy document, especially focused on the long-term planning of land use.

We attempted to update our General Plan in 2011. However, you goofed. You let the process get out of control, and the voters rejected the update.

A second attempt at an update is now underway. Now it's not out of control. It's a train wreck.

You abdicated your responsibility to an outside organization to select a process and participants, some of whom don't even live in Scottsdale.

You've sat back as the task force spiraled downward, and you've even excused the behavior of the members who have been the most offensive. In at least one case, one of you publicly congratulated that behavior.

Task force member Loren Molever publicly attacked other members recently with words like "hijack," "poppycock," "one-sided," "self-serving," "farce," and "sham." Why? Because they wanted the minutes of a task force meeting to accurately reflect what actually took place at a previous meeting.

As a result of Mr. Molever's behavior and silent approval from you, the four most qualified members of the task force—who have shared more factual information with the task force even than staff—have resigned.

Mayor Lane, the City Council, and the General Plan Task Force all formally adopted Scottsdale Leadership's Principles of Civil Dialog. Some of you have complained mightily when faced with lesser criticism than Mr. Molever directed at his colleagues. Councilwoman Milhaven comes to mind.

I'm reminded of the words of Councilman Robbins: "I certainly wouldn't want my children to behave that way. I wouldn't want the council to behave that way, or commissioners."

I hereby request that the City Council remove Mr. Molever from the General Plan Task Force, and make an earnest effort to avoid another disastrous failure of our General Plan Update.
