1. Request for Executive Session to:

- A. Discuss and consult with designated representatives of the public body in order to discuss security plans, procedures, assessments, measures or systems relating to, or having an impact on, the security or safety of buildings, facilities, operations, critical infrastructure information and information technology maintained by the public body, Arizona. A.R.S. § 38-431.03(A)(3) and (A)(9).

If authorized by a majority vote of the Scottsdale City Council, the executive session will be held immediately after the vote and will not be open to the public.
