Background

- August 29th Council requested staff examine the Phoenix Village Planning Model
- Phoenix Village Model is built on:
 - Population 1,460,000
 - Council Districts/ Village Committees
 - Village Committee Recommendation
 - └-Planning Commission Recommendation
 └-City Council Action



Advance Planning Work Program

- Policy and Plan Alignment
 - June 2005 Council Work Study Session
- Downtown Plan Update
 - Fall 2007 completion
- Greater Airpark Area Plan
 - 2006 State of the City Address
- South Scottsdale Plan
 - 2006 State of the City Address
- General Plan Update 2011/2012
 - State mandated update every 10 years



2011 General Plan Update

- The General Plan is the overarching policy document for the City
- Last updated in 2001 and ratified by the citizens in 2002
- State law requires it to be updated every 10 years – 2011/2012
- The process of updating the General Plan takes an average of 3-5 years
 - Requires extensive community outreach



What is Community Based Planning?

- Community Based Planning:
 - Encourages Community
 Involvement
 - Identifies Issues/ Opportunities
 - Examines Regional Influences
 - Proactively Plans for the Future
 - Achieves Policy and Plan Alignment
- Accomplished by creating planning areas in a city
- Each area has a long range community plan







Phoenix Village Planning

- Phoenix is divided into 15 "villages"
 - Each village has an approximate population of 125,000 – 150,000
- Each village has a Village Planning Committee
 - Appointed by Mayor and Council
 - Each village has 21 members
- Planning staff are assigned to each committee
- The Chair or Vice-Chair of a Village Planning Committee is on the Planning Commission
- Committee reviews all development cases before going to Planning Commission




Other Cities - Community Based Planning

- Staff analyzed 12 other cities
 - San Diego: voluntarily formed groups
 - Milwaukee: area plans included in General Plan
 - Sydney, Australia: overlapping area boundaries
- Findings from research include:
 - Cities start with long range planning goal
 - Formalized groups become current planning focused
 - Current planning emphasis offsets long-range planning goals



Scottsdale Currently – Long Range Planning



As stated in the General Plan, Scottsdale has a three level planning approach:

1. General Plan

Broad, citywide guiding principles


Character Plan

- Vision and role of an area
- Addresses the "edges"
- 3. Neighborhood Plan
 - Detailed, specific planning



Character Area Plans

- 24 CharacterAreas
 - Downtown, Desert and Dynamite Foothills- adopted
 - Downtown PlanUpdate- *underway*
 - 21 Character Areas remaining without final plans





Community Area Planning-Potential Areas

- Examined boundaries currently used in Scottsdale
 - Land Use, Current Planning, Code Enforcement, Police/ Fire, School Districts, Character and Strategic Areas, Census, Past Plans/ Policies
- Held brainstorming sessions with other departments in the City
 - Current Planning, Transportation, Economic Vitality, Preservation, Citizen and Neighborhood Resources




Community Planning Areas

- Shea Corridor
- Greater Airpark Area with Master Planned Communities
- Tonto Foothills

- Five potential Community Planning Areas
- Each area will have a Community Area Group
- Planning Commission participation
- Beginning in Fall 2007, each area will have a workshop to kick off the process






Issues Identification Community Area Plans 2011 General Plan Update

Community Area Planning – Alternatives

- A. Community Area Plans completed by 2010 and incorporated in General Plan update
 - Two plans created a year
 - Each area has a Community Area Group
 - Each Community Area Group's work will be completed with the adoption of the General Plan
- в. Complete remaining 21 Character Area Plans leading to General Plan update
 - Five plans created a year
 - Staffing levels, community outreach, Planning Commission and City Council timelines would not allow for completion of five plans per year



Community Area Planning – Alternatives

- c. Establish formalized Community Area Groups
 - Similar to Phoenix Village Model
 - Focus on current planning cases
 - Not long range oriented
- D. Complete long range work program and General Plan update with recommendation for implementation program
