

RESOLUTION NO. 6908

A RESOLUTION OF THE COUNCIL OF THE CITY OF SCOTTSDALE, ARIZONA DECLARING THE OFFICIAL CANVASS OF VOTES CAST IN THE CITY OF SCOTTSDALE RUNOFF/SPECIAL ELECTION HELD MAY 16, 2006; DECLARING THE ELECTION OF ONE CITY COUNCIL MEMBER; AND DECLARING OFFICIAL THE CANVASS OF VOTES CAST ON ONE QUESTION, PROPOSITION 402, VOTED UPON BY THE QUALIFIED ELECTORS OF THE CITY.

WHEREAS, the City of Scottsdale, Arizona, held a Runoff/Special Election on May 16, 2006 pursuant to Article 9, Section 1 of the Scottsdale City Charter, for the purpose of electing one council member for the City of Scottsdale; and

WHEREAS, a Special Election was also held on May 16, 2006 at the same time as the Runoff Election, for the purpose of presenting Proposition 402 to the qualified electors of the City; and

WHEREAS, Proposition 402 proposes a Permanent Adjustment to the State-Imposed Base Expenditure Limitation for the City of Scottsdale; and

WHEREAS, ARS § 16-642 requires that the City Council canvass the returns of the election no later than fifteen (15) days following the election; and

WHEREAS, the City Council, having canvassed the returns of the Runoff/Special Election, finds the returns to be as stated in this resolution.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Scottsdale, Arizona, as follows:

1. The results of the canvass having been determined, the official canvass of the City of Scottsdale Runoff/Special Election held on May 16, 2006 is as follows:
 - a) A summary of the number of votes cast in each district for each candidate for the office of council member is shown on Exhibit A, which is attached and incorporated by this reference.
 - b) A precinct group detail of the number of ballots cast and number of rejected ballots by district is shown on Exhibit B, which is attached and incorporated by this reference.

3. Proposition 402, which received a number of votes that was more than a majority of the votes cast, was approved by the qualified voters.




