No. 455), Section 1.403 (Additional conditions for specific conditional uses), Section 3.100 (Definitions) and Article XI (Land Use Tables), and any other affected sections, in response to recent Arizona voter-approved legislation (Prop. 207) legalizing recreational marijuana.
