Mayor Lane: We are running a little bit late and I know some folks have been waiting for us. So we will move right into our regular meeting. And I'm going to go ahead and initiate it from the get-go, if the city clerk will bear with me on that. I would like to call to order, the September 11th, City Council meeting our regular meeting.

We have Scottsdale police officers in front of us on the mezzanine if you have need for their service and the areas behind the Council dais are reserved for staff and the Council. There are facilities, restroom facilities over here to my left under that exit sign for your convenience.

Mayor Lane: And for the invocation this evening, we have Pastor Bruce Johnson, of the Scottsdale Presbyterian church. Pastor, welcome.

Pastor Bruce Johnson: Thank you, Mr. Mayor. Let us pray. Great God, we thank you for this day and we ask your blessing on the city and the City Council as they come to serve the people of this land. Lord, those who are old enough, we all in our memories go back to where we were 17 years ago when we first heard about the attacks on our city, on our country. And we pray again for those who suffered loss, grieving loss that day. We remember also how we were brought together as a people, where our differences were put aside, and we sought common good.

We thank you for the young people on that day who made the choice in the days and the years later to serve beyond themselves either through public safety, careers, or in law enforcement, medicine, teaching, and particularly for those young people who joined the armed forces of our country because of those dark days. We ask your blessings of safety on daughters and sons of our city, who are now serving as soldiers, sailors, airmen, Marines, and guardsmen. We lift up in particular, one daughter of our city, my own daughter, Air Force Pilot Captain Shelley O'Malley, and the other members of 318th Air Force Special Operations Squadron as they are about to deploy again. Be with them as they fly and keep them safe.

MAYOR'S REPORT

Mayor Lane: You know, I would just want to let the community know, certainly, that we had our own memorial events today with regard to the 17th anniversary of that tragic and horrendous terrorist attack that took 2,977 lives and unspeakable situation and circumstances. One of the things that we did today was our first responders spoke toward the people in their group that actually gave their lives. The distinction was made that the lives of the victims were taken and the lives of our first responders, fire, police, emergency service people, were given. Given up for the effort. They are all victims. They are all to be remembered.

And it's, it's something that we need not to lose sight of, that there is a lot of good in this world that was exemplified after the attack but there's a lot of evil too and unfortunately, we have to deal with both and not forget that there are certainly elements within the world that we need to stand guardian of our own country and our own people to make sure that we are taken care of, our of own public safety if you want to put it in that category of things. So I thank the pastor for his comments and prayer and for all of us to remember certainly those whose lives were taken and those that were given in that effort. So that is only sort of my Mayor's Report, I suppose of today's meeting. And we move on to the next order of business. There are no presentations.

PUBLIC COMMENT

Mayor Lane: We do have one request to speak under Public Comment and I just will describe the Public Comment so that there's no misunderstanding for future purposes. But we have Public Comment is reserved for citizens' comments regarding non-agendized items with no official Council action that will be taken on these items. Comments are limited to issues that are within the jurisdiction of the City Council. We do by virtue of issuing those particular independent elements to speak on non-agenda items, they are limited to three minutes each with a maximum of five speakers. There's no sharing of that time. And so the opportunity for Public Comment can be given also at the end of the meeting if it's needed. At this time, we have one request to speak, and it's Teri Todd. Teri, if you would like to come forward.

Teri Todd: Hello, everybody. A lot of familiar faces that have ridden in our carriages in the Parada Del Sol parade up there. My name is Teri Todd and my family owns and operates last existing stage coach wagon and carriage company in Scottsdale. We received an order to vacate Old Town by December 31st. In 2010, we had a stage coach custom built for the city of Scottsdale with the city name and the city logo on it. Scottsdale Stage Coach is the first ever to be modified to be street legal during February/March string training. We have two years left on our existing five-year contract which is reviewed annually and this year it was reviewed by Karen Churchard.

New safety concerns were reviewed after this past season on two night shifts, one of our carriages was hit by a golf cart and the other a beer bottle was thrown at one of our horses by a drunk passenger on the traveling bicycle bar. For the first time in three decades we are shutting down the night shifts and working days only until the sunset. It was shared with Ms. Churchard that we will be depending on the stage coach subsidy that has been subsidized by the city since 2004. It was made very clear to her and in other city, staff and emails that the revenue of a \$40 carriage ride is not going to survive that and minus the subsidy from the city, we will be out of business.

This is not an easy business. This is not a lucrative business. It's 16 hours a day of physical, hard work with our horses to safely stage them in Old Town. Total subsidy for the stage coach and special events is only \$12,000 a year and that goes down when we have bad weather days. In comparison, the singing cowboy holds a \$100,000, five-year contract for one horse, three hours a day, once a week. Earning half that amount operating a full-time business, I would really like an answer as to why the tourism department made the decision to pay almost double amount on the contract for one horse, three hours one day a week instead of paying half that amount on the high contract for several horses with stage coach rides, wagon rides and carriage rides and a full-time carriage service in Old Town.

In closing, our primary goal has always been to service the west most western town and keep it the western most western town to do, that we need your help. We petition that the city continue to honor the remaining two years of our contract, and if the city does decide to force us out, we will give you first right of refusal to purchase the Scottsdale stage coach that was made for the city. Any questions?

Mayor Lane: I'm sorry, Teri. This isn't an exchange. This is a non-agendized item but we have

taken your petition and we will consider.

Teri Todd: Thank you. You each have the cover letter, plus you have photos and you have the string of all the emails that went back and forth from the city. And you have the letter that we just received over the weekend asking us to vacate by December 31st. You have the Singing Cowboy sole source contract which we tried to get one and keep getting denied to do that. I just don't know what Scottsdale is going to do without Horse and Carriage. There is nobody else. There's a couple of people that I broker to when I can't get to an event. I repair all the wagon wheels. I can't just go to Walmart and get one, what is Old Town going to do?

Mayor Lane: Thank you for your information. Thank you so much. We got that. Another request to speak is Tim Cavin.

Tim Cavin: Good evening, Mayor. Good evening, Vice Mayor and City Councilmembers, people of Scottsdale. My name is Tim Cavin, I'm the president of Cavin Research Group. I'm requesting that we get a future calendar date for the city ordinance code 17-371 Paragraph G which is referring to towing and impound. We have a new technology that we have been trending on social media for the last eight months. It's a way I'm offering a way for Scottsdale to make a new revenue that has not been done before instead of traditional ways of towing and impounding. The laws that have inflected on the towing has been since 1989, adapted back in 2005, revisited in 2014, but nothing has changed. There's nothing further.

Mayor Lane: I'm sorry?

Tim Cavin: I'm just requesting that we get a hearing on 17-371 city ordinance code and paragraph G. If we can get that erased on how it says the immobilization, in fact, I will quote it right now.

Mayor Lane: This is not actually in the form of a petition to us, so we have not specifically direction on this kind of thing. But this is something that would have to be taken up with the City Manager's office at least at the initial stages to consider that.

Tim Cavin: Thank you.

Mayor Lane: All right. Thank you. All right.

CONSENT AGENDA

Those opposed with a nay. It's unanimous to Consent Agenda items 1 through 17. We have no regular Consent items. And we have no further Public Comment cards. I'm presuming that to be so.

Mayor Lane: So the original petition.....

Clerk Jagger: It has been filed with the clerk. We're good, Mayor.

Mayor Lane: Well, in our, our options here are to take no action on this petition or to take action in the form of direction to the City Manager to consider a report back to us or otherwise. Is there any action that is desired by the Council?

City Attorney Bruce Washburn: Mayor, I'm sorry. There is a third option and that is to direct that the matter be agendized at a future meeting.

Mayor Lane: Thank you very much, Mr. Washburn.

Vice Mayor Phillips: So I move that we direct the City Manager to investigate the matter and prepare a written response to the Council with a copy to the petitioner.

Councilwoman Littlefield: I will second that.

Mayor Lane: The motion then has been made and seconded to refer this to the City Manager for report back to us on that. I think we are then ready to vote. All those in favor of that, please indicate by aye. Those opposed with a nay. It's unanimous then to proceed with that motion,
