RESOLUTION NO. 2660

RESOLUTION DECLARING THE RESULT OF, AND ADOPTED CERTIFICATE OF RESULT OF, THE SPECIAL BOND ELECTION HELD ON FEBRUARY 18, 1986; ORDERING THE RECORDING OF SUCH CERTIFICATE.

BE IT RESOLVED BY THE MAYOR AND COUNCIL OF THE CITY OF SCOTTSDALE, ARIZONA:

After careful examination of the official return of the special bond election held in and for the City of Scottsdale on February 18, 1986, it is found and determined by the Mayor and Council as follows:

(A) A majority of those qualified electors voting at the aforementioned special bond election voted "For the Bonds" as shown on the attached Certificate of Result of Election;

(B) \$38,000,000 principal amount of City of Scottsdale General Obligation Bonds, Project of 1986, are therefore authorized to be issued and sold;

(C) The Mayor and members of this Council present this date will execute the attached Certificate of Result of Election;

(D) The Clerk is hereby directed to record the attached Certificate of Result of Election in the Office of the County Recorder of Maricopa County, Arizona, and to return said copy with the recording data shown thereon to the official records of this body.

CERTIFICATE OF THE MAYOR AND COUNCIL OF THE CITY OF  
SCOTTSDALE, ARIZONA, RELATIVE TO THE SPECIAL BOND ELECTION  
HELD ON FEBRUARY 18, 1986.

The Mayor and Council of the City of Scottsdale,  
Arizona, hereby certify as follows:

1. Pursuant to the resolution passed and adopted by the Mayor and Council on January 6, 1986, an election was duly held on February 18, 1986, for the purpose of approving the issuance and sale of General Obligation Bonds, Project of 1986, in the principal amount of \$38,000,000 to provide funds to purchase, make improvements, extensions, additions, renewals, replacements and repairs to the existing City of Phoenix Water System within the City of Scottsdale, including land, interests in land, water and rights to the same, buildings, facilities, equipment, furnishings and any other property of any kind, including joint facilities to be utilized with others, for the water system, by purchase, construction, exercise of the power of eminent domain or any other method of acquisition, whether within or without the corporate limits of the City; and to pay all legal, financial and other contingent costs in connection therewith.

2. The election had been conducted and the returns thereof made as required by law and that, in answer to the question submitted, 7,897 votes were "For the Bonds"; and 2,384 votes were "Against the Bonds".

3. Each and every person who voted at the special bond election was a qualified elector of the City of Scottsdale; proof of the due and regular publication of the notice of bond election has been made and filed with the Council and placed upon the minutes of the Council.

4. The majority of the votes cast at the election in answer to the question was in favor of the indebtedness as described in the question submitted at the election by the issuance and sale of \$38,000,000 principal amount of City of Scottsdale General Obligation Bonds, Project of 1986, and that the Mayor and Council hereby order the issuance and sale of all the bonds of this issue.





El Alcalde y el Concejo Municipal de la Ciudad de Scottsdale, Arizona, por el presente certifican lo siguiente:


1. De acuerdo con la resolución pasada y adoptada por el Alcalde y el Concejo Municipal el 6 de enero de 1986, una elección fue debidamente llevada a cabo el 18 de febrero de 1986, con el propósito de aprobar la emisión y venta de Bonos de Obligación General, Proyecto de 1986, en la cantidad principal de \$38,000,000, para proveer fondos para adquirir, hacer mejoramientos, extensiones, adiciones, renovaciones, reemplazos y reparaciones al existente Sistema de Agua de la Ciudad de Phoenix dentro de la Ciudad de Scottsdale, incluyendo predios, intereses en predios, agua y derechos a la misma, edificios, instalaciones, equipo, accesorios y cualesquiera otras propiedades de cualquier clase, incluyendo instalaciones conjuntas a ser utilizadas con otros, para el sistema de agua, por adquisición, construcción, ejercicio del poder de dominio eminente o cualquier otro método de adquisición, ya sea dentro o fuera de los límites corporativos de la Ciudad, y para pagar todos los costos legales, financieros y otros costos contingentes en conexión con todo esto.

2. La elección y los resultados de la misma se llevaron a cabo de acuerdo con la ley, y que, en respuesta a la pregunta que se presentó, 7,897 votos se dieron "A Favor de los Bonos", y 2,384 votos se dieron "Contra los Bonos".

3. Cada una de las personas que votó en la elección especial de bonos fue elector calificado de la Ciudad de Scottsdale; la prueba de que el aviso de la elección de bonos fue debida y regularmente publicada, ha sido realizada y presentada al Concejo Municipal, y archivada con las minutas del Concejo.

4. La mayoría de los votos emitidos en la elección, como respuesta a la pregunta, fue en favor del adeudo según se describe en la pregunta sometida en la elección para la emisión y venta de Bonos de Obligación General de la Ciudad de Scottsdale, Proyecto de 1986, en la cantidad principal de \$38,000,000, y que el Alcalde y el Concejo por la presente ordenan la emisión y venta de todos los bonos de esta emisión.
