RECOMMENDATIONS.

JUNE 30, 1952.

We Recommend THAT:

A proper recording or bookkeeping system be installed for the Magistrate. And that he now furnish the Clerk with the first duplicate receipt from his numbered quadruplicate receipt book. This duplicate receipt should be attached to his monthly report and remittance to the Clerk.

The Street Superintendent recap the statement he now furnishes the Clerk, so that, if so desired, a cost record could be obtained therefrom.

A Commissioner be appointed from the Common Council to act as head of the following Departments;

Finance Department (General Government)

Public Safety Department (Police, Fire & Inspectors)

Public Works Department (Streets & Highways).
