





- Cactus Path as far north as possible
- Darker concrete than current path
- 2 to 4 foot shoulder on current path
- 2 to 4 foot shoulder on new path
- Same elevation at wash crossings
- Additional vegetation south of path
- Design review prior to construction

REASONS FOR CONCRETE RATHER THAN GRAVEL

- Compliant with Americans with Disabilities Act
- · All-weather, firm, stable
- All bicycles, in-line skates, skateboards, razors
- Compatible with young bicyclists
- Strollers, wheelchairs
- Lower maintenance costs
- Minimal replacement costs
- Substantially longer life

























EXISTING ARIZONA CANAL USE


























