- 2. Continue the City Auditor's employment contract at a base salary of \$156,867.
- 3. Continue the City Treasurer's employment contract at a base salary of \$167,385.
- 4. Continue the City Attorney's employment contract at a base salary of \$213,875.
- 5. Continue the City Manager's employment contract at a base salary of \$218,000, and extend the period allowed for his receiving a moving allowance by 60 days.

Each of these changes to the employment contracts is to be effective as of the pay period beginning June 25, 2017.

Councilmember Korte seconded the motion, which carried 5/1, with Councilman Phillips dissenting and Councilwoman Milhaven absent.

With no further business to discuss, the Special Meeting adjourned at 8:29 P.M.
