





#### **3. Build Flood Control Structures to Protect Homes and Businesses in the Reata Wash** Flood Plain

Unfunded Amount: \$27,330,000 Other Sources: \$27,330,000 Total Project Cost: \$54,660,000

Building drainage systems to divert storm flows along Reata Wash from Pinnacle Peak Road to existing retention basins at WestWorld could alleviate temporary road closures and other disruptions caused by seasonal storms and provide 100-year flood protection for 4,600 structures in the area, which could save a typical mortgage holder several hundred dollars per year on flood insurance premiums.

#### 5. Modernize Computer Equipment Rooms to Protect City Servers

Unfunded Amount: \$691,600 Total Project Cost: \$691,600

Replace the battery backup power and the large cooling units that support the City's primary data center which has reached the end of its life cycle. Battery backup power allows the data center to remain operational during various weather or power provider events that can cause power disruptions throughout each year. The data center supports the primary data network, phone and server computing environments that run all of the applications and communications equipment required for the city to operate and supports all eServices for the citizens of Scottsdale.

Replace the batteries in Uninterrupted Power Supplies (UPS) at Public Safety Radio Sites. The batteries were installed in 2010 and have an average life of 7 years. The batteries are used when there is a commercial power interruption and provide the critical link between commercial power and generator power. If the batteries are not replaced, the UPS units would not be functional, and the public safety radio system would be vulnerable to a commercial power outage. This means that the Police and Fire radios might not transmit critical and time sensitive information.

The upgrade will enhance mapping and radio capabilities, improve vehicle dispatching, upgrade text-to-9-1-1 capabilities, increase efficiency in report writing and provide better case management. The current suite of systems will not be supported by the vendor after FY 2018/19.

The software used to build and maintain the city's public service websites, including ScottsdaleAZ.gov, ScottsdaleLibrary.org and ChooseScottsdale.com was purchased in 2006 and is no longer supported by the vendor. A new web content management platform is required to meet accessibility standards and provide a modern customer service experience for residents who access city services and information online.

- Projects like this, that involve the replacement or updating of public safety equipment and systems should be paid for from the General Fund.
- Shouldn't this have been built into the existing IT budget I went to the website and it appears to work fine.
- The citys website has become more difficult to use and does not work often with modern technology like cell phones. It is very difficult to find information and I can't get videos to work on my phone or tablet.
- The website is pretty terrible, especially for permits.
- This website does not work very well on my phone and I have difficulty using it. Updating the software is a much needed improvement to make it accessible by mobile devices. I would suggest Drupal or Joomla.

### **10. Replace Tennis Court Surface at Indian School Park and Scottsdale Tennis Center** Unfunded Amount: 3,497.1 Total project Cost: 3,497.1

Replace old asphalt tennis courts at Indian School Park and Scottsdale Ranch Tennis Center with post-tension concrete—a modern system that will dramatically increase the life of the courts and reduce ongoing maintenance and operating costs. These improvements will save an estimated \$3 million to \$4 million in maintenance and repair costs over the 30-year life of the concrete courts.

Add in programming in-house, Scottsdale Ranch Park requires renovated courts and lighting.
- "As a tennis player who plays consistently at Scottsdale Ranch Park and Indian School Park, the facility has fallen into somewhat of a state of disrepair. This has affected my frequency of play at both facilities, and, I'm sure, that of others. This city has had a long history of supporting tennis, and of being a destination for major city, regional and even national competitions. The facilities need to stay at a level to continue to service the local community as well as those visitors from out of town.
- I am in favor of raising the cost of court fees as well if need be. It is more expensive to LOSE a tennis center than to drive to one much further away, and not even in Scottsdale. I think the court fees could and should be raised to help offset the cost.
- Also, we would rather Scottsdale Ranch Park be updated, and look at ISP as a longer-term project, particularly with the potential for the entire area around it to be redone and reconfigured."
- As a tennis player who uses this facility, I believe this project should be a priority. The cracks in the courts are so bad it has become a safety issue. Some of the visiting teams we have played noted the cracks and mentioned they might refuse to use Indian School Park and play our team. If we move our team to another facility then you loose money which might help fund the resurfacing.
- Have first rate tennis facilities is very important to me and the community
- I play at the facility, and the courts I am put on are very un safe. Cracks, raised edges. I do not know when this facility was ever updated. League players pay fees to play on these court. This a hazard waiting to happen, and maintenance has not been kept up. With facilities closing, LaCamarilla, etc. why can this facility not be updated. Tennis is VERY much still a popular sport. Let's keep the facilities we have in proper condition to continue a fun active environment.





- "I understand items like this need addressed, but they should be classified under beautification and a totally separate and smaller budget set for things like this, senior centers and splash pads. Unless there is a public hazard to not resurfacing these courts.
- Apply for federal grants to assist in many of the beautification projects.
- Safety and security of citizens and city employers should always take priority!"
- If the savings are only \$3.5 million over 30 years for a \$3.5 million project it is not justified on savings, possibly on other basis, e.g., less injuries, more attractive and increased usage of the courts with this upgrade, the expenditure might be justified.
- Indian School Park tennis courts were built about 40 years ago. I'm guessing some were rebuilt at some point but their condition is awful and unsafe for play. Scottsdale Ranch is a bit newer but most of the courts are still old and cracked. I see them getting resurfaced often but cracks are back immediately. Not good for such a great facility.
- Indian school tennis center is a very out of date center that needs attention and renovation. The tennis center is home to thousands of guests and sometimes the guests are unable to play here. The average age range of participants here is about 40 years old. As we get older, we like to stay active however, some times we are unable to play due to cracked courts, heaving and sinking courts as well. Even freshly repaired courts start to crack within days of being finished because the underground Is what is causing all of the cracking on the courts.
- Much needed rebuild, post-tension concrete to eliminate court cracks and sustain long-term playability
- "My concern is about Comanche Park public tennis courts. They have been closed for 2 years. I have been a resident for over 20 years in McCormick Ranch. My family, friends and neighbors used to play at these courts. Also I think the courts are an asset and increase property values in the area. Sometimes you cannot get a court at Indian School or Scottsdale Ranch parks.
- The whole area including the basketball courts at Comanche Park and also Shoshone Park are in terrible disrepair. I would like the neighborhood to be as beautiful as it was when I moved here and as accessible. It's so pleasant to walk to a neighborhood court and play sports. Thank you"
- Need additional pickellball courts for fast growing sport
- Obviously not worth it if the cost is more then the savings expected over the life of the new courts.
- Pickleball courts would get more use. Has there been discussion about that?
- Please maintain and improve the quality of these widely used tennis courts. Post tension concrete will extend the life. Phoenix and Tempe have recently undergone similar renovations at Phoenix tennis center and Kiwanis. Scottsdale is due for the same
- Some of the courts at Indian School Park are sometimes potentially dangerous to play on because you can catch a shoe edge or a crack. The cracks are open or are sticking up depending on the time of the year. There could be a liability issue
- Some of these tennis courts should be converted to Pickleball courts. Pickleball is the fastest growing sport in the US. The few courts that Scottsdale owns are always busy during morning open times. Scottsdale needs more Pickleball courts.





- The funding saved can be used in other areas. The fixed cost of Maintenance will be almost nonexistent. The newly resurfaced courts crack within months, but this will last 30 YEARS at least. Best option!
- The old tennis courts at ISP and SRP desperately need to be resurfaced as they have all begun cracking and becoming safety hazards and eyesores to the patrons. Perhaps the investment in post-tension concrete could save the City some money in the long run as well, with the decreased maintenance costs.
- This is a very high priority project. Our citizens deserve quality playing surfaces for recreation and sadly many courts in the city have degraded. I favor using this strong construction technology to save money in the long run.
- This is needed a priority because the old asphalt courts are cracking and need to be repaired every year! Tennis players and tennis tournaments will no longer come to Scottsdale because the total facilities are not updated and unsafe. New lighting and fencing are also desperately needed. Just doing the tennis court surface will not be enough to keep players and events in Scottsdale. Look at the recent total renovations made at the Tempe & Phoenix tennis centers and that is what needs to be done in Scottsdale!
- This list shows Scottsdale Tennis Center; left out the word "Ranch" which can make this misleading. It's understood that funding this project would allow the budget for park court repairs to be used on unstaffed park courts such as Grayhawk, Comanche, Mtn. View, Ironwood, Paiute, etc. These parks don't get repaired as money goes to tennis centers first.
- This should only be done if it is really used and profitable--otherwise this should be waited on and not done now
- USTA tournaments require better maintained courts to facilitate USTA local, regional, and national tournaments/events. These events generate a substantial economic impact to the city. Scottsdale is the preferred location for many events. The USTA believes the rebuild of the tennis centers in Scottsdale to post-tension concrete is a high priority.
- With many of the city of Scottsdale parks closing tennis courts it is extremely important to keep up the tennis center courts at the two city tennis centers. These courts are typically full and it is harder to find available courts in a city known for its recreation and leisure activities. I also feel it should be a priority to reopen the tennis courts at Mountain View Park and Comanche Park to allow tennis in these neighborhoods for city residents.
- Need to see cost benefit analysis can't do them all and this seems very expensive to me. Many, many other tennis courts are available
- MAKE THESE PICKLEBALL COURTS...nobody plays tennis anymore. And there are no pickleball courts in this area.
- "I'm not sure it should be a priority, but for \$3.5 million, I would highly suggest some forethought in looking at converting some of the courts to Pickleball courts.
- It is the fasting growing sport in America. There are no public courts in the central area (between North and South). Phoenix area has high concentration of players due to weather and winter visitors that participate in their hometowns."





- Pickleball is the fastest growing sport and brings many people to the valley. Let's get more courts. Pickleball has changed my life and many others. Please please make this a priority
- Please consider converting some of these to Pickleball courts. It is one of the fastest growing sports and there is a lot of interest with lack of courts nearby.
- Why not try filling in the cracks for now to absolve liability if someone "trips" and falls. Then repaint to match. Same principle for filling potholes until you get enough federal funding to resurface entire street.
- Are these tennis courts are used on a regular basis?? I play pickleball at 3 different locations (public parks) in Scottsdale throughtout the week. There are always people waiting to get on the courts. I participated in a tournament last weekend at Horizon Park, and friends who didn't register right away were unable to play. Pickleball is a growning sport. I strongly recommend spending money to convert the courts to pickleball courts.
- "I find it crazy that you are willing to repair a tennis facility and not put in any pickleball courts when there are zero in the South Scottsdale area. As you have experienced with the Horizon and Cholla courts, build them and they will come. You literally had over 60 players at peak time the weekend before last at Cholla. It is to the point that if you do not get there early you will wait 15 minutes or more between leaving and getting back on the court.

Unfunded Amount: \$31,229.600 Total Project Amount: \$31,229,600

Renovate aging swimming pool and buildings at Cactus Aquatic Center to meet increasing demand and increase revenue. The current pool and building have many limitations including pool leakage, dated restrooms and showers, limited ADA access and security concerns and limited possibilities for improvement. Cactus Pool host 144,000 guest annually and is the only City aquatics facility that can host swimming and diving competitions. The renovated facility is projected to increase revenue by \$125,000 annually.

  park and outdoor setting. The pool and aquatics facility however is outdated, undersized and well
  behind other regional state of the art facilities. In addition to improving the quality and potential
  revenue stream associated swimming and diving competitions, the average city resident would benefit
  from upgraded club and recreational facilities.
- As a swim parent of two SAC swimmers who have benefited from the SAC program, the facility could use major updating. The level of success of the program could further attract high caliber swimmers (collegiate graduates training for the Olympics, and former Olympians continuing to pursue a career in swimming) if the facility rivaled some of the other pools in the metro area (ie Phoenix Country Day school; Skyline High School). As well, there would be potential for hosting larger swim meets (Pro Series) if the renovations were completed. Scottsdale is a destination for many travelers/visitors; yet it would be great to include competitive swimming facility along with the other city offerings.
- Cactus pool is in particular need of attention. Pool and facilities should be kept open during construction as new facilities are built in a separate area of the property. This would allow revenue streams while construction underway.
- Cactus pool is up for a major update. Our city needs to invest in it so we can grow our future champions!
- Even though my competitive swimmer will be in college by the time this project is probably complete, the ability for the City to host bigger meets and gain exposure would be an advantage in addition to the added revenue.

- My family is fairly new to the area but have been using the cactus pool for sometime; it is old and in need of serious updating, especially when comparing it to other pools. Please prioritize this project as it serves many kids/families and stands as a beacon for Scottsdale to how the city appreciates its health and wellness of its residents.
- My son is a club swimmer who uses Cactus pool as his practice facility. We also have meets there. While
  we love our club, these kids deserve a better place to train. The facility is old and run down. These kids
  put up to 6 days a week in the water. They should have a beautiful place to swim. We pay a ton of
  money both as taxpayers and to the club. The bathrooms are gross and always smell like urine. The
  building is outdated. Places like Phoenix Swim Club have a beautiful facility and while I realize it is a
  privately funded pool, there is no reason we shouldn't have something similar. Thank you.
- No bond money is needed. The City is currently in violation of the State Constitution Gift Clause by refusing to charge market rates for lane rental to the current competitive swim club. The City currently loses, or gifts to the individuals running that club, \$326,300/year. There is a competitive swim club ready, willing and able to pay full market rate that the City refuses to allow into Cactus pool. That club charges their swimmers more, pays their coaches more and pays the City less. Taxpayers do not need to keep funding this.
- Renovating the Cactus Aquatic Center would provide thousands of guests better, updated facilitites that better meet ADA requirements.
- "The aquatic facilities, specifically Cactus Pool, benefit hundreds of youth swimmers, many of which go on to earn scholarships and swim in colleges and universities across the country.
- Swimming is also a lifelong exercise that will help people stay healthy and live a higher quality life."

Repair failing lakes and irrigation from McKellips Road to Thomas Road in the Indian Bend Wash. The lake system is showing signs of aging and failure due to punctures in the lake lines, erosion of the lake edges and leaks in the spillway system. The irrigation systems are outdated, undersized and perform inadequately. Updating materials and technologies will lower annual operating costs, enhance water conservation and quality, resolve lake edge erosion and allow more effective use of park open space area.

Unfunded Amount: \$1,224,300 Total Project Cost: \$1,224,300

Replace, upgrade or install new lighting systems for sports fields at Laguna and Pima schools, Horizon Park and at two currently unlit fields at Scottsdale Sports Complex to meet increased demand and current sports lighting standards, and to minimize light spillage in adjacent neighborhoods. The newly lit fields at Scottsdale Sports Complex would generate approximately \$10,000 per year in additional revenue and offset any utility costs associated with the new lights. Additionally, these lights will eliminate the annual need to use diesel generators for lighting in some areas of the Phoenix Open and reduce light spillage into the surrounding area.

I would be more than happy to discuss economic impact or what we could do."
- Good to do but make sure our LEDs do not flicker like some in Phoenix are doing.
- I sure hope the plan is to add lighting to the two fields that do not have lights at Pima Traditional School. It is a shame that there are only two usable fields and the two other fields have to sit empty after the sun starts to go down. With all of the reinvestment in South Scottsdale and new families moving in, it seems like a no brainer to maximize field space for youth sports. Right now all of the field space is concentrated in the northern part of the city.
- I'm not sure why it is on the list if it will provide a return as mentioned. I don't feel beautification is a "necessary" priority on Capital Improvements over Safety and Security, but when it generates the type of revenue to exceed the expense, I don't understand the request.





- "Recreational Youth sports are severely underserved in the local area. Scottsdale Sports Complex is the one facility that local teams have access to (truly local teams, not travel/select clubs that blanket the Valley's parks and facilities).
- This would be a huge boost to local players and make SSC a top-flight regional facility."
- Sounds like it would help to pay for itself.
- Sports lighting and additional sports fields are huge, especially in the southern part of the city. My family lives within the Pima boundaries and upgrading the lighting in that area would be great. Just a question why don't all four fields have lights? Is that a city thing or a SUSD responsibility? Is that part of this project as far as the lights at Pima are concerned? My little one will play baseball on the small field and right now there are no lights on that field. I've gone to games at that field that had to be cut short because there's no lighting. Couldn't you tap into the existing light poles to add lighting to those fields? Regardless, youth sports are huge and contribute significantly to neighborhoods. SUSD just invested \$20 million plus on Pima. Seems like adding lights to a couple of the fields would have been part of their scope. I know that's the school district's project, but I just mention it as Pima is part of this particular project. I do appreciate the city is asking for community input for these projects though.

- Why can't the teams pay for use and should fund improvements
- Pima fields currently have 2 lit and 2 unlit fields. Upgrading the lights to provide at least one more lit field would allow more games and usage of this complex.
- My Understanding is that the lighting project would only be a replacement of the current lighting at Pima Elementary fields, and not additional lighting for the other two fields at the location. I think the board should consider additional lighting, as it would instantly double the number of fields useable after dark, opening the potential for more efficient field usage, and potential revenue from additional field rental. Additionally, lighting all fields at Pima would increase field safety, and potentially deter vandalism and field trespassing.

The new facility has a projected increase of \$25,000 in annual Leisure Education revenue.

The track has excessive damage and constant repairs are needed resulting in training delays for police, fire and municipal departments.

The current facility is over 20 years old, undersized, does not meet the national training curriculum standards, and limits the type of training police officers and personnel can receive, creating a safety issue.

By moving the station closer to the geographic center of the area it serves and improving access, the response times for emergency services will improve significantly.

This project would add approximately 7,800 square feet to the jail, including two additional cells, new intake and release points, supervisor offices, and attorney/client interview rooms. The police station would be enlarged and modernized to meet current needs and the entire facility will be brought up to standards of the Americans with Disabilities Act.

The October exploratory meeting at Winfield for the Ashler Hills park "wish list" provided ample evidence of local support for a dog park. Replace the fire department's only utility truck that went out of service in 2010 once it could not meet safety requirements. The City has not had funding to replace the unit and currently relies on automatic aid partners to provide a response vehicle to support fire ground activity and response to Hazardous Materials and Technical Rescue Incidents. Response into most of Scottsdale can be as long 30-45 minutes. Acquisition of a utility truck will improve the reliability of a timely response to working incidents in Scottsdale.

- A utility truck is a tool to provide basic services, and more importantly for the safety of Public Safety and first responder personnel. These personal cannot operate safely at night without proper lighting, and firefighters can't go into burning buildings if they don't have air. It's also a key component of Rehabilitation a Personnel, especially in the summer months, allowing them to work better, stronger, longer, and more importantly safely. This unit should be a basic component of your Fleet.
- Absolutely! Give the fire department what it needs to protect us!!
- As a former public safety chair and county emergency service coordinator when in Illinois, I encouraged thoughtful but justified consideration of needed equipment. Sometimes I went to bat for a needed vehicle, and sometimes I asked that replacement vehicles be prioritized over the course of years. Never did I dismiss a recognized need., I suspect that after nine years, it's time to be sure this is in the purchase schedule sooner than later.
- Critical equipment. Even though it is meticulously cared for needs replacement. I heartily support this acquisition.
- Having to borrow another cities utility truck causes a delay for our firefighters. If they need a new air bottle replaced they have to wait a long tim for pHx or mesa utility truck to respond. Do the right thing and provide our city with the appropriate equipment and stop borrowing from our neighbors.
- "I have no relationship with the City but I'm curious as to why it is necessary to build this with a custom cab chassis when most departments are using commercial cab chassis. The last spec I wrote for a vehicle like this was under \$500,000.
- I listen to the fire department scanner often. Scottsdale Fire has to pull Utility 29 which comes from the Phx Sky Harbor airport. They used to have a utility truck at station 6, they truly do need one right away.





- I worked in Scottsdale as an Emt and I've seen the level of calls that take place here. It's important that we do anything we can to maintain a safe city and keep the public's trust in our first responders capabilities.
- It is unacceptable for a city our size to not have this resource available.
- Our guys definitely need this truck to perform and save lives of Scottsdale citizens!!
- "Projects like this should take priority over changing the city flag or public art.
- Public safety should always take priority and the city council should acknowledge that, especially this time of year with all of the large scale events."

- The city/ fire department should consider utilizing a FEMA or HUD grant to replace this apparatus with a "whole cost" or "partial cost" option to save taxpayers money and allow the city to focus on other projects.
- The customers safety depends on the safety of the emergency responders and their ability to provide the best service possible. The utility truck is another tool that may provide the necessities to the emergency responders, during any serious response, in order to help aid and maintain their safety during such responses. Any department in the valley that provides emergency services to a community the size of Scottsdale should have their own utility truck. The Automatic Aid system is by far better than any mutual aid system in the country, but being dependent on the surrounding departments to provide a utility truck is a delay in time to emergency responses, when lives may be on the line.

There is a documented history spanning 25 years of extreme resistance to developing the lands around the gated Communities and strong arming City of Scottsdale developments. ie: The Summit, Foothills Academy, Apartments by Westland, and pretty much any new proposal to develop and address building to the needs of a growing multi-age community needs, outside of their gates. Even in the language of their promotional website the language they use promotes age discrimination... quote "An Adult Disneyland" and the list of activities and Clubs are ADULT only. Del Webb promoted multi-age community, promising a children's playground/swingset and slide and as the membership spends millions of dollars annually, it has still resisted approval to building one. I'd be happy for the City of Scottsdale Governing body to start cracking down on this type of age discriminating, practice in this area. They can start, by addressing the needs of Multi-age needs of their community and build a play park that is inclusive of a much broader range of children's ages... this language sends a clear message that residents in this area, that they do not want school age children, and God forbid "teens" using their space.

- With all the interest in pickleball in north Scottsdale, this park would be the perfect site for at least 6 pickleball courts. Keep it simple.

- I live very near this proposed project area and I think an additional bridge is a priority. Vehicle traffic is fairly busy during normal days, and traffic increases considerably during special events nearby. Also, speeding is an ongoing problem on this road, and drivers do not always obey the school zone flashing lights at the nearby elementary school. This road is also highly-used by bicyclists, and the roadway narrows dangerously on the eastern end of the bridge for northbound traffic, which makes it hard to give bicyclists their prescribed three feet of room. Thank you for listening.
- I travel this road every day. The driving northbound to merge from two lanes into one and then immediately go into a curve is dangerous. I've seen many people drive too fast to try and pass other cars to merge. I've also seen drivers get too close to cyclists which are often on this road. The additional bridge would provide for a safer walking, cycling ,and driving path and I am in support.
- Many many accidents have occurred on the current narrow bridge
- Needed to improve pedestrian and bicyclist safety.
- No need to extend bridge. Current configuration helps as deterrent to reduce traffic speeds. Not enough traffic to justify the cost
- Please build the additional bridge along Thompson Peak Parkway over Reatta Wash. This is a major safety issue as I have lived in DC Ranch for 12 years and have noticed significant increases in vehicle traffic near Copper Ridge School. Head on vehicle accidents are at great risk here as a 4 lane divided

road merges into 2 lane undivided road along a narrow merging curve at speeds usually above 40 mph. Vehicles constantly swerve into opposite lanes and it is only time before a major accident occurs on both sides of this bridge. Please find the funding to build this project as it is a real public safety issue. At a minimum, the Scottsdale road engineers should take action and review this bridge site to realign the roads on both sides of the bridge to allow safer merges onto bridge and eliminate the "temporary road closed" signs and temporary unsightly closed gate that have existed at this location since 1996. Please take action now!!! Your attention to this is greatly appreciated. I welcome a phone call to discuss this and I am ready to get involved to help assist in any way.

- The bend in the road and the narrowness of the existing bridge makes this a hazard and potential for head on collisions.
- The current diversion from NB Thompson Peak to the current bridge is a hazard, and being on a curve in the road doesn't help. The curve is way too sharp, even at the 35mph speed limit. It is a significant choke point in both directions. The approach on SB Thompson Peak is too short. Both approaches to the single bridge on Legacy Blvd are nearly four times as long and seem to work.
- The current traffic pattern is unsafe for cars traveling northbound, because of the blind corner feeding cars onto the existing bridge. Many times I've been behind cars that are unsure of the road that hav slammed on their brakes not knowing where to turn. It also makes this 1,000' of roadway extremely dangerous for bicyclists traveling northbound on TPP. With the volume of traffic on TPP, this is a priority.
- "The lane detours over Reata Wash on TPP and Legacy are a risk to pedestrians, bike riders and mototrists.
- Regardless the reason for these unfortunate situations, the City should have taken the bull by the horns to complete the crossings over the wash. The City has been collecting substantial property taxes for more than 15 years and has yet to deliver."
- The second bridge in this location should have been built at the developer's expense when this area was being developed.
- There is currently insufficient traffic to justify this project with all of the other high priority projects on the list.
- This bottleneck is becoming more of an issue every day. It is hard to understand how you can take 2 lanes either way down to one lane either way crossing the pass. It was obviously set up to have the bridge since you can see where it is supposed to be located as the convergence takes place. This is a long overdue need.
- This bridge is long overdue. The dangers for pedestrians and bikers is severe with the current situation. The sidewalk is heavily trafficked by children walking to school and the layout is misleading to drivers when the road suddenly narrows to a single lane.
- This is a critical safety improvement that is needed.
- this is way overdue narrowing down to one lane each direction is silly and unsafe
- This should be ranked as the number 1 priority. This bridge should have been completed when the road was first put in place. It is ridiculous that the road is narrowed to 2 lanes and then goes back to 4 lanes, 2 in either direction. This would also improve the safety factor of using the road.





- Traffic in this area is becoming dangerous and this would improve safety and driving conditions
- "Very much needed. Only time until someone dies on that bridge. Very unsafe."
- We live at DC Ranch and use the East Gate entrance exclusively. This area going down to one lane (from both directions) at odd angles has and will remain a problem. If you are a bicycle rider, you enter this area at your own risk. I'm not one but have witnessed many close calls due to either the drivers not slowing down or the bikers moving into the driving lane. I can't blame either as a driver can't get a good look at this area due to the curve of the road in each direction as it enters the bridge area. The walk path over the bridge has no protection for a jogger or walker. The only fix is to bypass the bridge and get on a trail that goes out of the way to pass through the wash. Since the bridge was completed, the area south and east on Thompson Peak has exploded with growth. Silverleaf, Windgate, etc. have added many hundreds of drivers not to mention the added traffic of vendors and folks cutting through to areas south. A bridge would be much better use of funds as opposed to a park in the same general area. Thanks for your time.
- With increasing amounts of traffic on Thompson Peak Parkway, diverting traffic onto a single bridge becomes more dangerous for cyclists, pedestrians and motorists. Constructing a second bridge is long overdue.
- Zero need. No traffic issues. No pedestrian issues. Complete waste of money.
- Currently a bottleneck situation especially with events at Westworld and TPC. Please consider this project a priority
- Dangerous to vehicles and bicyclists in the single bridge current configuration, made especially so by the bridge's design. Adding the second bridge, as the roadway was clearly built for, would aide the flow of traffic and allow for better, and safer, separation between vehicles and bicycles.
