ACTION

Adopt Resolution No. 11728 Authorizing the City to file a petition for review of FAA action related to Flight Routes from Sky Harbor International Airport or seek other available legal remedies.

Background.

In September 2014 the FAA changed longstanding flight routes in and out of Sky Harbor Airport. In doing so, the FAA "used computer software to model the noise impact of the proposed route changes," and determined that the projected noise levels would not have a significant environmental impact.

The public reaction to the new flight routes was extremely negative. Ultimately, the City of Phoenix and one of its historic neighborhood associations mounted a legal challenge in the Federal Circuit Court for the District of Columbia. The basis for the Phoenix legal challenge was that the FAA did not follow required procedures for environmental and other review.

This litigation was in the D.C. Circuit for multiple years. Ultimately, the D.C. Circuit decided in favor of the City of Phoenix and its fellow petitioners and issued a decision vacating the FAA's 2014 order implementing new flight departure routes from Phoenix Sky Harbor Airport. The D.C. Circuit determined that (1) the FAA did not properly consult with the City; (2) the FAA did not properly notify citizens of the changing flight routes before they went into effect; and (3) the FAA failed to follow its own regulations. During the litigation, the Phoenix parties and the FAA agreed that the FAA would conduct a two-step process. In the first step, the FAA revised the West departure routes consistent with its agreement with the Phoenix. The second step was for the FAA to complete the required environmental review and hold a series of workshops to discuss the new routes. The agreement stipulated that both East and West departure routes would be discussed as part of Step Two.

The FAA held a series of workshops and opened its docket for public comment. In addition, the FAA also published alternative "concepts" of East departure routes for discussion. In response to this Council's direction, the City also submitted comments as well as a detailed analysis prepared by a consulting firm (JDA) which proposed a modification to the first alternative concept discussed by the FAA which would have restored more of the East departure traffic more toward unpopulated areas such as the Salt River. However, the FAA issued its decision on January 10, 2020 declining to make any changes to the new East departure routes adopted in 2014. The FAA's actions are subject to further review in a federal circuit court.

ANALYSIS & ASSESSMENT

Recent Staff Action

Staff from the City Attorney's Office and the City Manager's office have been working together on this matter for several months to participate in the FAA proceedings and continuously monitor the situation.

Policy Implications

The new East flow flight routes adopted by the FAA have significantly impacted a substantial number of citizens. Some citizens even formed an advocacy group to participate in the FAA proceedings. Scottsdale is shouldering an unfair burden of the new flight routes. Left unchallenged, the new FAA flight routes are likely to continue to unfairly impact Scottsdale and its citizens.

Significant Issues to be Addressed

Whether to pursue further legal remedies regarding the FAA's implementation of new flight routes.

Community Involvement

Community involvement in this issue has been ongoing. City staff have received numerous communications from citizens regarding the issue and a substantial number of citizens also submitted comments in the FAA proceedings.

RESOLUTION NO. 11728

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SCOTTSDALE, MARICOPA COUNTY, ARIZONA, AUTHORIZING THE CITY ATTORNEY AND CITY MANAGER TO FILE A PETITION FOR REVIEW OF FEDERAL AVIATION ADMINISTRATION ACTION AND SEEK FURTHER LEGAL REDRESS AS APPROPRIATE

WHEREAS, the Federal Aviation Administration ("FAA") has adopted new flight departure routes from Sky Harbor International Airport which substantially impact the City of Scottsdale and its citizens; and

WHEREAS, the City has determined that the adoption of the new East flow flight routes from Sky Harbor International Airport are not in the best interest of the City; and

WHEREAS, on or about January 10, 2020, the FAA adopted its order further implementing the new East flow flight routes;

WHEREAS, it is in the best interest of the City to seek legal review of the FAA action.

NOW, THEREFORE, LET IT BE RESOLVED, by the City Council of the City of Scottsdale, Maricopa County, Arizona, as follows:

Section 1. The City Attorney and the City Manager, or designees, are hereby authorized to take such acts as necessary for the City to file a petition for review of the FAA action or actions implementing new flight routes or seek such other avenues of legal redress that may be available to the City related to East flow departure or arrival routes from Sky Harbor International Airport.

Section 2. The City Attorney and the City Manager, or designees, are further authorized to take such further actions as may be necessary to carry out the purposes of this resolution.
