BACKGROUND

This request is for a Series 10 (Beer and Wine Store) liquor license for an existing location with new owner. This has been a licensed location most recently operating with liquor since 2019, as a beer and wine store.

APPLICANT'S PROPOSAL

The applicant is seeking a favorable recommendation on a Series 10 (Beer and Wine Store) liquor license. This allows a liquor store retailer to sell beer and wine liquors, only in the original package, to be taken away from the premises of the retailer and consumed off the premises.

The applicant has indicated that this establishment will serve liquor between the hours of 9:00 am and 10:00 pm; however, due to State liquor license processing requirements, they are not required to notify the City or the State if they change their hours of operation.

IMPACT ANALYSIS

Zoning

This site is zoned C-3 (Highway Commercial). The C-3 district allows beer and wine store as a permitted use. The applicant has been notified of the City's expectation that the business will operate as a beer and wine store/retail as defined by City Code.

If the application is approved by the Department of Liquor Licenses and Control, the applicant should receive their license from the State within 105 days of original application.


