





### Officer investigates open burglary cases and solves them

Between 9/23/13 and 11/10/13 **Officer Ryan Mercier** investigated a number of commercial burglaries in which suspects were stealing beer kegs and selling them to retail establishments for the return fees. Two suspects were involved in at least four separate Scottsdale cases, as well as a number of open cases in Phoenix. Through the use of video surveillance from some of the establishments, a suspect was identified and confirmed with one of the victim's employees via photo line-up. Officer Mercier developed information as to this individual's whereabouts and solicited Phoenix PD's assistance in apprehending him from an address in their jurisdiction. The offender subsequently confessed his involvements to Officer Mercier in the Scottsdale and Phoenix cases, as well as identifying his co-conspirator. By conducting surveillance on the second suspect's residence, Officer Mercier was successful in apprehending him as he left the house. This offender also confessed his involvements, resulting in both individuals being charged with burglary, theft and trafficking in stolen property. A number of officers participated in this endeavor, which would not have been successful without everyone's efforts. Great teamwork!

She only got one mile in three hours before her hands had blisters. She drank both liters of water she had purchased. Not knowing what to do and with no one stopping to help her, she called the non-emergency number and within minutes, Officer Mulvey was on scene. Officer Mulvey placed her in her patrol car along with her groceries and took her home. The resident stated "she probably saved my life. Not her job to be a taxi but she was there in my time of need." The resident also wanted to send a "Thank you" to the "awesome" call takers in Communications for sending Officer Mulvey out to help her.

Sgt. Macari received a card from an elderly couple whose vehicle broke down along 96th Street. **Officer MacArthur** assisted this couple with getting them a ride home and coordinating with the tow company to get their vehicle picked up in a reasonable amount of time. ### **Kudos to Officers from Deputy County Attorney**

Hello officers. As I long ago intended, here is an email that I hope you share with your supervisors because it outlines your incredible work in a case that will finally put a 23-year old, violent and already career criminal, away for a long time. For those that might read this email, Daron Holmes is a young man, who we now know has committed at least seven armed robberies. He got away with the first four. Because of the work of **Detective Hiner and Officer Savage**, he is going to prison for the last three. That is thanks to the work of many people, but it would not have happened without Detective Hiner and Officer Savage.

Officer Savage, you keenly spotted a car coming out of a residential neighborhood while responding to an armed robbery. You caught on to thier backdoor escape route, and picked up details corroborating the broadcast description. Given their sneaky escape route, many would have missed them. You also took it upon yourself to stop these violent young men. And, you did excellent reporting work that made their prosecution go forward. You reported on scene that night to the detectives details fully justifying your actions and the legality of your stop. You also fully detailed those facts in your supplement. That made a tremendous difference in court when Mr. Holmes baselessly attacked your actions that night. Your testimony was excellent and professional, while you were questioned in an obnoxious manner by defense counsel.

Detective Hiner, you preserved crucial evidence needed to convict Mr. Holmes for both this robbery, and the others. Mr. Holmes clothes became crucial to prosecutions for two other robberies. They provided not just direct proof, but modus operandi evidence for a previously unsolved robbery. You preserved them as evidence. Additionally, you saved the evidence in this case necessary to show dishonesty by Mr. Holmes' family when they came in to lie and try to suppress evidence. When his family kept calling to pester you, you recorded the conversation. That recording became crucial for pretrial litigation.

Mr. Holmes is now headed to prison for 12.5 to 20 years. Thank you.

#### A letter to the Chief

I wanted to take the opportunity to write to you about my experience with the Scottsdale Police Department. A little over a month ago I moved from NYC to Scottsdale. I'm permanently disabled with a rare progressive neurological disease called FTD – Frontotemporal Dementia. FTD is untreatable, unstoppable and incurable. I made the move here for a variety of reasons including economics and quality of life.

My first week here I met and became friendly with a Scottsdale Police officer who was off duty a Starbucks off Osborn Road. Lisa (Taylor) is a veteran of the Scottsdale PD and works traffic investigations. Lisa was very forthcoming and honest and over the next few weeks helped me tremendously in letting me know the area trouble spots, what to look out for with local drivers and intersections prevalent to accidents. Lisa, a Scottsdale native, is a wonderful person as well as an excellent representative of your department and city. Over the next few weeks, I managed to meet about a half dozen officers from Scottsdale PD at the Starbucks on Hayden/Osborn Rd. Some I know by name, others by face. All the police I've met have been outgoing, friendly and professional. They have been extremely welcoming to me as a NYC foreigner into their community. One day an officer came into Starbucks asking if someone parked their Mini Cooper in the disabled parking spot. I raised my hand, quilty as charged. I forgot to hang the blue disability placard on the mirror. It was on the seat. In NYC it's a ticket, period. I explained to the officer I had a rare form of dementia. FTD does not primarily affect memory like Alzheimer's but the part of the brain that controls behavior, planning, organizing and language. The officer took the time to listen to me about FTD and took note of things to look up on the web. I can't tell you how thrilled I am that your officers take interest in learning about a rare disease in a time crunch society. Unfortunately I'm a bit disorganized because of FTD so the officer helped me with my car papers. We realize I threw out the plate sticker by accident when I put on the new plate just days earlier. I felt like a buffoon but he was extremely professional, nice and patient. Helping me organize and writing something down the officer told me that DMV was 5 minutes down the road and suggested I go there. I did shortly after he left.
