Order Modification Fee	Fee assed for each modification to a confinement, screening, or treatment program order resulting from non-compliance with the initial order or request by the defenant.	\$25.00 Per Order to change
Court Bonds Forfeited	Penalty for defendant not appearing for specific court date without rescheduling through the Court. The bond is forfeited to City.	Varies per case
Court Copy Fees	Cost of the document or case history per printed page.	\$0.50 Per Page
Court NSF Check Fees	Non-sufficient fund check charge.	\$25.00 Per Check
Default Fee	When a defendant fails to appear in a civil violation or a civil traffic violation case, or fails to satisfy in full a civil sanction imposed in a civil violation or a civil traffic violation case, a default fee is assessed for each charge.	\$65.00 Per Charge
Warrant Fee	When a defedant fails to appear, comply, pay on a criminal case, a default fee will be assessed per issuance of a warrant.	\$65.00 Per Warrant
Defensive Driving	Monies allocated to multiple entities.	Varies Depending on School
Assessment for Family Offenses, Harassment and Stalking	When a person convicted of a violation of section 13-2921, 13-2921.01 or 13-2923 or an offense listed in title 13, chapter 36, a fee to be deposited in the State of Arizona Domestic Violence Fund shall be assessed	\$50.00 per charge
Court Enhancement Fees	All charges are assessed a court enhancement fee that provides funding to maintain and enhance collection and management of monies assessed or received by the Court per statute.	\$30.00 Per Charge
FARE Delinquency Fee	FARE-Fines/Fees and Restitution Enforcement Program-is a private/public partnership between the Arizona Supreme Court, Administrative Office of the Court (AOC) and Affiliated Computer Services (ACS) to provide enhanced collection services to Arizona Courts.	\$35.00 Per Case

Home Detention Electronic Monitoring (HDEM) Setup Fee	The defendant will be charged a one-time nominal fee to cover the court's cost of processing the application and monitoring the participant's progress throughout the program.	\$30.00 Per Initial HDEM order
Jails-Housing Fee	Reimbursement for the cost of housing the defendant in jail as part of sentencing.	Jail housing per diem rate is set by the Maricopa County Dept of Finance
Contract Administration Fee	Fee assessed to the creation/establishment or modification of a payment contract.	\$10.00 Per Contract
Jails-Initial Booking Fee	Reimbursement for the cost of booking the defendant in jail as part of sentencing.	Jail booking rate is set by the Maricopa County Dept of Finance
Probation Fee	Fee assessed for each year that the case is placed on summary probation.	\$150.00
Local Judicial Collections	All fines not paid on the day of sentencing will be assessed a \$20 Time Payment fee - \$7 of this fee remains with the City in a Special Revenue Account. Use of funds must be approved by the Administrative Office of the Courts. Funds are to be used to enhance and maintain the ability to collect and manage monies assessed or received by the Court. This is assessed once per <u>case</u> .	\$20.00

Diversion Fee	Diversion program fees where the defendant completes a diversion program and the case is dismissed in lieu of finding the defendant guilty of the charge. The account also includes fees associated with missed jury trials that have been calendared.	\$150.00 Per Diversion
Personal Service Fees	Fee assessed for cost of personal service for photo radar cases in which there has been no other response from the defendant.	\$32 .00 per service inside state of Arizona, \$50 per service outside state of Arizona
Public Defender	Cost of public defender service.	As Determined by the Judge
Minimum Clerk Fees	Fee assessed for records requests when hard copy documentation is provided	\$17.00 Per Case
Research Fees	Fee assessed in conjunction with records requests when additional case research is required	\$17.00 Per Case
