

Open Database License Agreement ¹

This Open Database License is made between the City of Scottsdale (“City”) and You (as defined below). By, and as a condition of the City’s permission for, viewing and/or downloading Content from the Portal, You acknowledge acceptance and agreement with the terms and conditions of this License, as follows:

1.0 Definitions of Capitalized Words

“Collective Database” – Means this Database in unmodified form as part of a collection of independent databases in themselves that together are assembled into a collective whole. A work that constitutes a Collective Database will not be considered a Derivative Database.

“City” – Means the City of Scottsdale.

“Content” – Means the collection of material available on this Database, which includes the information, independent works, or other material collected into the Database. For example, the content of the Database could be factual data or works such as images, audiovisual material, text, or sounds.

“Data” – Means statistical, factual, quantitative, or qualitative information that is created, maintained or in the possession of a City division, department, office or employee.

“Database” – Means the collection of material (Content) arranged in a systematic or methodical way and individually accessible by electronic or other means offered under the terms of this License.

“Database Access Right” – Means the right to access Publishable Data pursuant to this License.

“Derivative Database” – Means a collection of material derived from and/or based upon the Database, and includes any translation, adaptation, arrangement, modification, or any other alteration of the Database or of a Substantial part of the Content. This includes, but is not limited to, Extracting or Re-utilizing the whole or a Substantial part of the Content in a new Database.

“Derivative Work” – Means any work that is based in any manner or to any extent upon the Content, including, without limitation, any work that uses the Content in a modified form.

“Extraction” – Means the permanent or temporary transfer of all or a Substantial part of the Contents to another medium by any means or in any form.

“License” – Means this license agreement between You and the City of Scottsdale for access to the Open Database.

“Licensor” – Means the City of Scottsdale.

“Open Data” – Means Publishable Data that is available online, in an Open Format, with minimal legal encumbrances on use or reuse.

“Open Database” – Means the collection of Publishable Data available from the City of Scottsdale through its Portal.

“Open Format” – Means any widely accepted, nonproprietary, platform-independent, machine-readable method for formatting Data that permits automated processing of such Data and facilitates search capabilities.

“Person” – Means a natural or legal person or a body of persons corporate or incorporate.

“Portal” – Means the page on the city’s website where Publishable Data is made available in an Open Format.

“Produced Work” – Means a work (such as an image, audiovisual material, text, or sounds) resulting from using the whole or a Substantial part of the Contents (via a search or other query) from this Open Database

“Publicly” – Means to Persons other than You or under Your control by either more than 50% ownership or by the power to direct their activities (such as contracting with an independent consultant).

“Publishable Data” –means Data and Content that has value for decision-making, is not Protected or Sensitive and that has been prepared for release on the Open Data Portal for non-commercial purpose.

“Re-utilization” – Means any form of making available to the public all or a Substantial part of the Contents by the distribution of copies, by renting, by online or other forms of transmission.

“Substantial” – Means substantial in terms of quantity or quality or a combination of both. The repeated and systematic Extraction or Re-utilization of insubstantial parts of the Contents may amount to the Extraction or Re-utilization of a Substantial part of the Contents.

“Use” – As a verb, means doing any act that is restricted by copyright or database rights, if any, whether in the original medium or any other; and includes without limitation distributing, copying, publicly performing, publicly displaying, and preparing derivative works of the Database, as well as modifying the Database as may be technically necessary to use it in a different mode or format.

“You” – Means a Person exercising rights under this License who has not previously violated the terms of this License with respect to the Database, or who has received express permission from the Licensor to exercise rights under this License despite a previous violation.

Words in the singular include the plural and vice versa.

2.0 What this License covers

2.1. Legal effect of this document. This License is:

- a. A license of applicable copyright and neighboring rights;
- b. An agreement in contract between You and the City of Scottsdale.

2.2 Legal rights covered. This License covers the legal rights in the Database, including:

a. **Copyright.** Any copyright or neighboring rights in the Database. The copyright licensed includes any Content created by the City, but does not cover the copyright over the Content created independently of this Database and reproduced for informational purposes, such as applicant submittals and studies created and/or produced by other Persons. See Section 2.4 for details.

b. **Contract.** This is an agreement between You and the Licensor for access to the Database. In return you agree to certain conditions of use on this access as outlined in this License.

2.3 Rights not covered.

- a. This License does not apply to computer programs used in the making or operation of the Database;
- b. This License does not cover any patents over the Contents or the Database; and
- c. This License does not cover any trademarks associated with the Database.

2.4 Relationship to Content in the Database. The individual items of the Content contained in this Database may be covered by other rights, including but not limited to copyright, patent, data protection or privacy rights, and this License does not cover any rights (other than Database Rights or in contract) in individual Contents contained in the Database. For example, if used on a Database of images (the Contents), this License would not apply to copyright over individual images, which could have their own separate licenses, or one single license covering all of the rights over the images.

3.0 Rights granted

3.1 Subject to the terms and conditions of this License, the Licensor grants to You a worldwide, royalty-free, non-exclusive, terminable license to Use the Database. These rights explicitly exclude commercial use.

The rights granted cover, for example:

- a. Extraction and Re-utilization of the whole or a Substantial part of the Contents;
- b. Creation of Derivative Databases;
- c. Creation of Collective Databases;
- d. Creation of temporary or permanent reproductions by any means and in any form, in whole or in part, including of any Derivative Databases or as a part of Collective Databases; and
- e. Distribution, communication, display, lending, making available, or performance to the public by any means and in any form, in whole or in part, including of any Derivative Database or as a part of Collective Databases.

3.2 Licensor reserves the right to release the Database under different terms, or to stop distributing or making available the Database. Subject to Section 10.4, all other rights not expressly granted by Licensor are reserved.

4.0 Conditions of Use

4.1 The rights granted in Section 3 above are expressly made subject to Your complying with the following conditions of use. These are important conditions of this License, and if You fail to follow them, You will be in material breach of its terms.

4.2 **Notices.** If You Publicly convey this Database, any Derivative Database, or the Database as part of a Collective Database, then You must:

- a. Do so only under the terms of this License or another license permitted under Section 4.4;
- b. Include a copy of this License (or, as applicable, a license permitted under Section 4.4) or its Uniform Resource Identifier (URI) with the Database or Derivative Database, including both in the Database or Derivative Database and in any relevant documentation; and
- c. Keep intact any copyright notices and notices that refer to this License.
- d. If it is not possible to put the required notices in a particular file due to its structure, then You must include the notices in a location (such as a relevant directory) where users would be likely to look for it.

4.3 **Notice for using Contents.** Creating and Using a Produced Work does not require the notice in Section 4.2. However, if you Publicly Use a Produced Work, You must include a notice associated with the Produced Work reasonably calculated to make any Person that uses, views, accesses, interacts with, or is otherwise exposed to the Produced Work aware that Content was obtained from the Database, and that it is available under this License.

- a. Example notice. The following text will satisfy notice under Section 4.3:

Contains information from the City of Scottsdale Open Database Portal, which is made available here under the Open Database License.

“Open Database License” should contain a hyperlink to the URI of the text of this License. If hyperlinks are not possible, You should include the plain text of the required URI’s with the above notice.

4.4 Share alike.

a. Any Derivative Database that You Publicly Use must be only under the terms of:

- i. This License;
- ii. A later version of this License similar in spirit to this License; or

b. Extraction or Re-utilization of the whole or a Substantial part of the Contents into a new database is a Derivative Database and must comply with Section 4.4.

c. **Derivative Databases and Produced Works.** A Derivative Database is Publicly Used and so must comply with Section 4.4. if a Produced Work created from the Derivative Database is Publicly Used.

d. **Share Alike and additional Contents.** You must not add Contents to Derivative Databases under Section 4.4(a) that are incompatible with the rights granted under this License.

4.5 **Limits of Share Alike.** The requirements of Section 4.4 do not apply to the following:

a. You are not required to license Collective Databases under this License if You incorporate this Database or a Derivative Database in the collection, but this License still applies to this Database or a Derivative Database as a part of the Collective Database;

b. Using this Database, a Derivative Database, or this Database as part of a Collective Database to create a Produced Work does not create a Derivative Database for purposes of Section 4.4; and

c. Use of a Derivative Database internally within an organization is not to the public and therefore does not fall under the requirements of Section 4.4.

4.6 **Access to Derivative Databases.** If You Publicly Use a Derivative Database or a Produced Work from a Derivative Database, You must also offer to recipients of the Derivative Database or Produced Work a copy in a machine readable form of:

- a. The entire Derivative Database; or

b. A file containing all of the alterations made to the Database or the method of making the alterations to the Database (such as an algorithm), including any additional Contents, that make up all the differences between the Database and the Derivative Database. The Derivative Database (under a.) or alteration file (under b.) must be available at no more than a reasonable production cost for physical distributions and free of charge if distributed over the internet.

4.7 Technological measures and additional terms:

a. This License does not allow You to impose (except subject to Section 4.7 b.) any terms or any technological measures on the Database, a Derivative Database, or the whole or a Substantial part of the Contents that alter or restrict the terms of this License, or any rights granted under it, or have the effect or intent of restricting the ability of any person to exercise those rights.

b. Parallel distribution. You may impose terms or technological measures on the Database, a Derivative Database, or the whole or a Substantial part of the Contents (a “Restricted Database”) in contravention of Section 4.74 a. only if You also make a copy of the Database or a Derivative Database available to the recipient of the Restricted Database:

i. That is available without additional fee;

ii. That is available in a medium that does not alter or restrict the terms of this License, or any rights granted under it, or have the effect or intent of restricting the ability of any person to exercise those rights (an “Unrestricted Database”); and

iii. The Unrestricted Database is at least as accessible to the recipient as a practical matter as the Restricted Database.

c. You may place this Database or a Derivative Database in an authenticated environment, behind a password, or within a similar access control scheme provided that You do not alter or restrict the terms of this License or any rights granted under it or have the effect or intent of restricting the ability of any person to exercise those rights.

4.8 Licensing of others. You may not sublicense the Database. Each time You communicate the Database, the whole or Substantial part of the Contents, or any Derivative Database to anyone else in any way, the Licensor offers to the recipient a license to the Database on the same terms and conditions as this License. You are not responsible for enforcing compliance by third parties with this License, but You may enforce any rights that You have over a Derivative Database. You are solely responsible for any modifications of a Derivative Database made by You or another Person at Your direction. You may not impose any further restrictions on the exercise of the rights granted or affirmed under this License.

5.0 Fair dealing, Database exceptions, and other rights not affected

5.1 This License does not affect any rights that You or anyone else may independently have under any applicable law to make any use of this Database, including without limitation:

a. Exceptions to any Copyright and similar rights, including: Extraction of Contents from non-electronic Databases for private purposes, Extraction for purposes of illustration for teaching or scientific research, and Extraction or Re-utilization for public security or an administrative or judicial procedure.

b. Fair dealing, fair use, or any other legally recognized limitation or exception to infringement of copyright or other applicable laws.

5.2 This License does not affect any rights of lawful users to Extract and Re-utilize insubstantial parts of the Contents, evaluated quantitatively or qualitatively, for any purposes whatsoever, including creating a Derivative Database (subject to other rights over the Contents, see Section 2.4). The repeated and systematic Extraction or Re-utilization of insubstantial parts of the Contents may however amount to the Extraction or Re-utilization of a Substantial part of the Contents.

6.0 Warranties and Disclaimer

6.1 The Database is licensed by the City “as is” and without any warranty of any kind, either express, implied, or arising by statute, custom, course of dealing, or trade usage. Licensor specifically disclaims any and all implied warranties or conditions of title, non-infringement, accuracy or completeness, the presence or absence of errors, fitness for a particular purpose, merchantability, or otherwise. The city gives no expressed or implied warranties, representations, or conditions of any kind, with respect to the Data or the Derivative work. The city does not warrant the content, accuracy, currency or completeness of the Data or Derivative Work, or concerning the results to be obtained from queries or use of the Data or Derivative Work, including without limitation, implied warranties of merchantability, quality, and fitness for a particular purpose. All Data and Derivative Work is expressly provided as is and with all faults. The licensed user is responsible for ensuring the accuracy, currency and completeness of all products (including maps, reports, displays and analysis) produced from or in connection with the Data or Derivative Work and assumes all risks as to the results and performance of the Data or Derivative work. The licensed user shall have no remedy against the City if the Data or Derivative Work provided is defective in any way, including but not limited to the recovery of consequential, incidental, or indirect damages, punitive damages, or any other damages claimed to be suffered by the user or any third party as a result of use of the Data or Derivative Work. This section survives the termination of this license.

7.0 Limitation of liability

7.1 Subject to any liability that may not be excluded or limited by law, the Licensor is not liable for, and expressly excludes, all liability for loss or damage however and whenever caused to anyone by any use under this License, whether by You or by anyone else, and whether caused by any fault on the part of the Licensor or not. This exclusion of liability includes, but is not limited to, any special, incidental, consequential, punitive, or exemplary damages such as loss of revenue, data, anticipated profits, and lost business. This exclusion applies even if the Licensor has been advised of the possibility of such damages. The City, its elected and appointed officials, officers, agents and employees will not be liable for any direct, indirect, incidental, consequential

or special damages (including, without limitation, loss of use, time or data, inconvenience, commercial loss, lost profits or savings, or the cost of computer equipment and software), to the full extent that liability may be disclaimed by law, or for any third party claim against the Licensed User.

7.2 The City, its officials, officers, agents, and employees will not be responsible for any claim, including any claim by a third party, for any liability, loss or damage that may arise in connection with any erroneous information contained in the Data or Derivative Work.

8.0 Termination of Your rights under this License

8.1 Any breach by You of the terms and conditions of this License automatically terminates this License with immediate effect and without notice to You. For the avoidance of doubt, Persons who have received the Database, the whole or a Substantial part of the Contents, Derivative Databases, or the Database as part of a Collective Database from You under this License will not have their licenses terminated provided their use is in full compliance with this License or a license granted under Section 4.8 of this License. Sections 1, 2, 7, 8, 9 and 10 will survive any termination of this License.

8.2 If You are not in breach of the terms of this License, the Licensor will not terminate Your rights under it.

8.3 Unless terminated under Section 9.1, this License is granted to You for one year.

8.4 Reinstatement of rights. If you cease any breach of the terms and conditions of this License, then your full rights under this License will be reinstated:

- a. Provisionally and subject to permanent termination until the 60th day after cessation of breach;
- b. Permanently on the 60th day after cessation of breach unless otherwise reasonably notified by the Licensor; or
- c. Permanently if reasonably notified by the Licensor of the violation, this is the first time You have received notice of violation of this License from the Licensor, and You cure the violation prior to 30 days after your receipt of the notice. Persons subject to permanent termination of rights are not eligible to be a recipient and receive a license under Section 4.8.

8.5 Notwithstanding the above, Licensor reserves the right to release the Database under different license terms or to stop distributing or making available the Database. Releasing the Database under different license terms or stopping the distribution of the Database will not withdraw this License (or any other license that has been, or is required to be, granted under the terms of this License), and this License will continue in full force and effect unless terminated as stated above.

9.0 Indemnity

To the full extent permitted by law, the Licensed User will indemnify, defend at his/her sole cost and expense, and hold harmless the City, its elected and appointed officials, officers, agents and employees from and against any claim, expense, injury, liability, loss or damage of any kind, nature and description (including, without limitation, incidental and consequential damages, court costs, attorney's fees and costs of investigation), that may arise, directly or indirectly, in whole or in part, from the Licensed User's review, download or use of the Data or Derivative Work. The Licensed User's obligation to indemnify, defend and hold harmless the City arises even if the claim may be groundless, false or fraudulent; the obligation will arise at the time the City tenders the claim to the License User and continues at all times thereafter.

10.0 General

10.1 If any provision of this License is held to be invalid or unenforceable, that does not affect the validity or enforceability of the remainder of the terms and conditions of this License and each remaining provision of this License shall be valid and enforced to the fullest extent permitted by law.

10.2 This License is the entire agreement between the parties with respect to the rights granted here over the Database. It replaces any earlier understandings, agreements or representations with respect to the Database.

10.3 If You are in breach of the terms of this License, You will not be entitled to rely on the terms of this License or to complain of any breach by the Licensor.

10.4 **Choice of law and venue.** This License takes effect in and will be governed by the laws of the State of Arizona. The parties agree that for any action in law or equity brought to enforce any provision of this License, to the extent not otherwise prohibited by law, jurisdiction and venue shall be solely in the state or federal courts located in Maricopa County, Arizona. The Licensed User consents to the venue and jurisdiction of such courts upon Licensed User viewing, downloading or using any Data or Derivative Work from the City's website.

10.5 **Remedies.** In the event of a breach or threatened breach of this License by the Licensed User or any employee, representative or agent of the Licensed User, the City shall be entitled to injunctive relief to enforce this License. The City may also pursue other remedies, at law or in equity, all of which shall be cumulative and non-exclusive.

10.6 **Attorney's Fees and Costs.** In any action in law or equity, the prevailing party will, in addition to any other remedies, be entitled to recover its actual costs, including, without limitation, actual reasonable attorney's fees and other legal expenses incurred to bring, maintain or defend any such action from its first accrual or notice thereof through any appellate proceedings and collection proceedings.

10.7 **Interpretation.** This is the entire agreement between the parties. No oral or written prior or contemporaneous agreement shall have any effect, nor shall any subsequent agreements have any force or effect unless made in writing and signed by both parties. This License was made in and shall be interpreted and performed pursuant to the laws of the State of Arizona without regard to any conflict of law's provisions.

10.8 Waiver. The waiver of any default or breach will not constitute a waiver of any other right under the License or of any subsequent breach or default. If the City does not exercise or enforce any legal right or remedy described in the License or available to the City by applicable law, the City's inaction will not be considered a formal waiver of the City's rights. The City's waiver of any of the terms or conditions will be effective only if the waiver is made, in writing, and signed by the City's duly authorized representative.

10.9 Surviving Provisions. If any of the terms or conditions of the License is determined to be invalid by a court of competent jurisdiction, then the remaining provisions will nevertheless remain in full force and effect.
