

The Scottsdale Water Conservation Office is offering a hot water recirculation system rebate to water customers who install this water conservation device in their home. A hot water recirculation system means a system that consists of pipes with a motor driven pump that recirculates water between a water heater and hot water faucets. The rebate is offered to encourage a reduction of indoor water use.

1. Who Can Apply?

The Hot Water Recirculation System Rebate is available to single-family residential properties that receive water from the Scottsdale water system. The applicant must be the property owner or the party legally responsible for paying the water bill. Rebates are not available to builders or for systems that were included in new construction.

2. What Features Must the Hot Water Recirculation Systems Have to Be Eligible?

The system must be new and a “listed” product (such as “UL” approved) and must be installed per its listing.

The hot water recirculation model must have either an electrical timer programmable to a minimum of two cycles so the device runs only when needed or a pump on-off switch must be provided at a minimum of one fixture. Remote on-off switches may be utilized in place of an on-off switch at the fixture.

Tankless water heaters and point-of-use water heaters are not approved systems for this program.

3. How Do I Apply?

4. How Much is the Rebate?

The rebate is a credit that will be applied to the water bill. There is only one rebate per customer.

The hot water recirculation system must remain in the possession of the original purchaser or remain at the original installation address for at least one year from the date of purchase.

The rebate amount is limited to actual cost (excluding tax and installation) of the system or a maximum of \$200, whichever is less.

Funds are limited. Rebates will be processed until funds are depleted.

5. Is a Building Permit Required?

Installation of the hot water recirculation system must meet city code requirements and permitting requirements. Go to One Stop Shop at 7447 E. Indian School Rd, Suite 105, Scottsdale, AZ 85251, phone 480-312-2500 and get a Minimum Permit or obtain your permit online at www.scottsdaleaz.gov/onestopshop. Inspection Services will inspect your system after installation as part of the permit process.

SUMMARY OF STEPS TO RECEIVE A REBATE

- Obtain a minimum permit from One Stop Shop.
- Install system, or have system installed.
- Request Inspection Services to inspect installation of system. Monday through Friday inspections; call 480-312-5796. Saturday inspections; call 480-312-4656 and leave a message requesting a hot water system inspection, your name, address, and phone number. An inspector will return calls to schedule Saturday inspections.
- Include permit number and inspection date on application.
- Include make and model on application.
- Complete and sign the application form.
- Submit copy of itemized receipt of system with application to the Water Conservation Office.
- Approved applications will be credited to the water bill within two billing cycles.
