- 1. Call to order and establish a quorum (Roll Call) The Meeting was called to order at 8:32 a.m. with a quorum of the members Members present Eloy Yndigoyen, Jeffery Greene, Daniel Stewart, Mary Grier, and Evelyn Racette. - 2. Discuss Executive Director position, work plan, and goals —Evelyn Racette, President Evelyn Racette discussed the Executive Director position and explained that this position would not only handle administrative tasks, but would also create a process for potential deals.
