1. Approval of the April 27, 2022 Regular Meeting Minutes.

Seconded by Vice Chair Young, the motion carried unanimously with a vote of six (6) to zero (0) by Chair Higgs, Vice Chair Young, Commissioner Gonzales, Commissioner Ertel, Commissioner Scarbrough, and Commissioner Serena.

2. 11-AB-2021 (Johnson Abandonment)

Request by owner to abandon fifteen (15) feet of Public Road Right of Way along the northern property line of a parcel located at 12501 E. Mountain View Road with Single-family Residential (R1-43) zoning.
