- Ensure the City manages its own water supply.
- Need to balance water conversation plans with ongoing development needs.
- Provide City Council with data on total water use, including drinking water, reclaimed water, and non-potable water.
- Staff to consider and plan for worst case scenarios, which are predicated on existing information.
- Increase additional water sources.
- Explore infrastructure improvements as soon as possible, including possibly building lift stations.
