Councilmember Korte: Thank you. Mayor. I would like to make the following motion which is a little bit long. One, to continue the City Manager's contract at a salary of \$278,889 to take effect in the first pay period in the next fiscal year. Two, to continue the City Auditor's contract at a salary of \$183,960 to take effect in the first pay period in the next fiscal year. Three, to continue the City Treasurer's contract at a salary of \$203,697 to take effect in the first pay period in the next fiscal year. Four, to continue the City Clerk's contract at a salary of \$181,529 to take effect in the first pay period in the next fiscal year. And to stay in effect through December 31st 2020. And five, to appoint Deputy City Attorney Joe Padilla to be the Acting City Attorney effective June 27th, 2019. To serve until a new City Attorney is appointed or Mr. Padilla's appointment is terminated by further action of the Council. He is to receive a 15% salary increase to take effect in the first pay period in the next fiscal year and to be applied after any market adjustment or merit increase he has been awarded in his permanent position. The 15% salary increase will terminate when he is no longer the Acting City Attorney.
