Councilwoman Littlefield seconded the motion, which carried 7/0, by a roll call vote, with Mayor Lane; Vice Mayor Whitehead; and Councilmembers Klapp, Korte, Littlefield, Milhaven, and Phillips voting in the affirmative.

2. Proclamation and Declaration of Emergency

Request: Pursuant to Scottsdale Revised Code Section 10-3, consider approving a motion either continuing or terminating the Emergency Proclamation declared by Mayor Lane on May 31, 2020, as a result of the looting and unrest which began on May 30, 2020. The Emergency Proclamation is scheduled to expire on June 7, 2020, unless further extended.

Councilwoman Klapp seconded the motion, which carried 7/0, by roll call vote, with Mayor Lane; Vice Mayor Whitehead; and Councilmembers Klapp, Korte, Littlefield, Milhaven, and Phillips voting in the affirmative.
