Mayor Lane: So we will proceed with what amounts to Item 2, and it's the Arizona Corporation Commission Public Comment. And for this purpose Okay, we have Shane Stone, our Management Assistant who will address this item for us. Welcome.

Shane Stone: I'll take another scoot back there. My name is Shane Stone, I'm a Management Assistant to City Manager Thompson. On January 21st, at the January 21st City Council meeting a citizen petition was received from Mr. Robert Cappel. The petition asked for the City to intervene in the Arizona Corporation Commission's consideration of rate increases by Liberty Utilities. The Council voted 7-0 to direct that petition to the City Manager for further investigation into the matter. Liberty Utilities is seeking to increase wastewater rates to the more than 2000 customers, including more than 1000 Scottsdale residents, by 32 and a half percent. In the interest of the potentially impacted residents of Scottsdale, the requested investigation determined it would be proper for the City to formally oppose the rate increases and provide information requested by the petitioner through submission of comment to the Corporation Commission. The item before you would authorize the City Manager, on behalf of the City, to participate in the Corporation Commission hearing through public comment opposing the rate increases requested by Liberty Utilities. I appreciate your consideration of this item and yield to any questions you may have.

Mayor Lane: Thank you Mr. Stone. Do we have any questions for Mr. Stone on this subject? Seeing none. Yes, go ahead.
